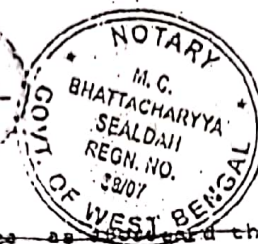
And whereas the surety is interested in the welfare of the said trainee and therefore has agreed to these presents as surety.

And whereas one of the terms & conditions of the said engagement of the trainee is that the trainee shall complete the prescribed training tech III under the DEE/G and after such completion shall accept service under the government and serve the govt. for a minimum period of 5 yrs and if the trainee deserts service or resigns from service during the period of training or thereafter without the written consent of the government or is discharged therefrom for misconduct or any other offences as enumerated in the deed the trainee shall repay on demand by the government the whole cost of training and say other amounts excluding traveling and running allowance drawn by the trainee from the Government under these terms & conditions.
