Sub.: Clarification regarding Out-of-Turn promotion to sportsperons.

(ii) Railway Board's letter no. 2016/E(Sport)/5(1)/12/Rio-Olympic 2016, dated 25.04.2017 & 2018/E(Sports)/4(3)/4/Policy, dated 17.08.2018.

Kind attention is invited to DMW's letter mentioned under reference (i), wherein some clarification was sought as under :

- (i) Whether instructions issued vide Board's letter dated 25.04.2017 still exists even after issue of Railway Board's letter dated 17.08.2018 ; and
- (ii) Whether GMs are competent to grant Out-of-Turn promotion to Group 'B' Post.

In regard to (i) above, it is clarified that the policy of out-of-turn promotion of sportspersons to Officer grade laid down vide both the Board's instruction no. 2016/E(Sport)/5(1)/12/Rio-Olympic 2016, dated 25.08.2017 and instruction no. 2018/E(Sports)/4(3)/4/Policy, dated 17.08.2018 are in vogue. Sportspersons, fulfilling the conditions laid down in either of the letters, can be promoted to officer grade .

With regards to (ii), it is clarified that in terms of para 207 of Indian Railways Establishment Code (Vol.I), appointment to Group 'B' Service by promotion of staff employed on the Railway may be made by the General Manager.
