- 1. Last date for submission of application for re-engagement is within 16.00 hrs of **19.01.2024**.
- 2. The eligibility criteria for selection of retired Supervisors/staff for re-engagement will be as follows:
 - All the retired Supervisors/staff who have not attained 64 years 6 months on the (i) closing date of notification (TO ENSURE AT LEAST SIX MONTHS SERVICE IS AVAILABLE AFTER RE-ENGAGEMENT)
 - APARs of last 3 years immediate before retirement should be "Very Good". If last (ii) three years APARs are not available, previous three years' APARs will be considered.
 - Re-engagement shall be subject to prescribed medical fitness for the category in (iii) which they are re-engaged.
 - 3. Suitability /competency of the applicants will be adjudged by the nominated committee before re-engagement.
 - 4. Re-engaged retired staff will be terminated as and when regular incumbents report to GSU/Asansol.
 - 5. The re-engaged retired Supervisor/staff can be terminated by giving one month's notice. In case of gross negligence/misconduct/irregularities, the re-engagement may be terminated with immediate effect.
 - 6. The duty hours of the re-engaged retired employees will be regulated under Railway Servants (Hours of Duty and Period of Rest) Rules, 2005.
- 7. Jurisdiction of work of re-engaged retired employees will be decided by CPM/GSU as per requirement.
- 8. Monthly remuneration of re-engaged retired employees will be determined in terms of Railway Board's letter No.E(NG)II/2007/RC-4/CORE/1, dt.24/10/2019.
