This is in continuation to this office earlier notification of even number dated 10.01.2024.

Based on the willingness/unwillingness received from all the candidates borne on the integrated seniority list, published vide Main/Extended and Stand-by lists to notification ibid, the list of willing candidates, in order of seniority, found eligible to appear for appearing in the CBT (to be conducted by NAIR on **25.02.2024** - **there shall be no supplementary examination, Exam city will be- Kolkata**) for the 70% (Spl. Drive) Selection (CBT) for the year 2023-24 for formation of a panel of AFAs (Group-B), is enclosed as **Annexure-A**. *Any discrepancy found or reported in the list may be intimated to this office, through proper channel, for necessary rectification, if any, by **24.01.2024**.*

It is further informed that **online** pre-selection coaching classes for the ensuing 70% selection for formation of a panel of AFAs (Group-B) will be held on and from **29.01.2021** to **09.02.2024** as per the enclosed programme schedule at **Annexure-B**. Necessary Meeting i.d. and Password will be informed to all concerned in due course.
4. The controlling officer of the respective offices should get the **acknowledgement from the candidates** to the effect that they have noted the contents of this notification and send a confirmation to **Secy. to PFA/E.Rly./Kolkata** by **25.01.2024** without fail.
5. In this context, it is reiterated that **APARs** of the candidates should be kept in readiness so that there is no inadvertent error/delay in complying with the timeline prescribed by Board. Information/confirmation regarding availability of APARs for the years **2017-18, 2018-19, 2019-20, 2020-21 & 2021-22** in respect of the willing and eligible candidates under your control should be sent by **09.02.2024**, positively. Similarly, DAR/Court Case/Criminal Case clearance should also be kept ready.
6. After publication of written result (CBT), requisite medical examination before viva-voce of the successful candidates as per Para 206.2 of IREM(Vol.I – 1989) should be ready to be conducted at a short notice.
