विषय:-Payment of family pension, death gratuity and other dues to the family on death of a Government servant during service – Regarding.

The undersigned is directed to say that the Covid-19 pandemic has claimed lives of several Government employees during the recent surge. In many cases, the deceased employees were the sole bread-winners of their family and the casualties have left families devastated and in an urgent need for funds for livelihood. It is, therefore, incumbent on the Government to ensure that the family pension and other entitlements in respect of the deceased employees are released to their families expeditiously.

- 2. The completion of the process for sanction of family pension and its disbursement through the Bank may take some time, as it involves reference to PAO and CPAO. To deal with such situations, Rule 80-A of the CCS (Pension) Rules, 1972 provides for payment of provisional family pension and also provisional death gratuity, pending issue of the Pension Payment Order (PPO).
- 3. Department of Pension & Pensioners' Welfare has issued instructions vide OM No. 1/11/2020-P&PW (E) dated 29th July, 2020 for sanction of provisional family pension by the Head of Office immediately on receipt of a claim for family pension and death certificate from the eligible family member, without waiting for forwarding of the family pension case to Pay & Accounts Office (PAO). Rule 80-A provides for payment of provisional death gratuity by the Head of Office once the family pension/death gratuity case has been forwarded to the PAO.
- 4. In view of the above, all Ministries/Departments and their attached and subordinate offices are requested to strictly comply with the rules/instructions as brought out above and to ensure that payment of provisional family pension is commenced by the Head of Office immediately on receipt of the claim (with death certificate) from the eligible family member and payment of provisional death gratuity is made to the nominees/family members immediately after forwarding the case to the PAO.
- 5. Simultaneously, the action may be taken on priority basis for disbursement of regular family pension through the Bank and for payment of other entitlements of the family on death of the Government servant. It may be ensured that the PPO for family pension is issued and disbursement of regular family pension is commenced by the Bank not later than one month of the receipt of the claim for family pension.
- 6. For facilitating expeditious disbursement of all the entitlements of the family on death of a Government servant, two separate notes- one in respect of the employees under Old Pension Scheme and the other in respect of the employees under National Pension System are also enclosed as Annexure-I and Annexure-II, respectively.

# (1) Entitlements of family on death of a Government servant under Old Pension Scheme

#### A. Family Pension:

Amount: 50% of last pay for a period of 10 years from the date following the date of death. Thereafter a 30% of last pay.

(Enhanced family pension @50% of pay is payable for 10 years in all cases without reference to the length of service of the deceased employee, as per amended Rule 54(3))

Eligibility of family members: Family pension will be paid to members of family in the following order::-

Documents required to be submitted by the claimant for family pension: (i) Application in Form 14, (ii) a copy of death certificate, (iii) proof of relationship, (iv) proof of date of birth, (v) copy of first page of the Pass Book, (vi) copy of PAN card. (vii) Specimen signature and (viii) PP size photographs

<sup>\*\*</sup>A child or sibling suffering from a mental or physical disability shall be eligible if their overall income from other sources is less than the entitled family pension admissible on death of Government servant plus dearness relief thereon.

# Action to be taken By HOO:

- Sanction provisional family pension to eligible family member immediately on receipt of claim, without waiting for forwarding of case to PAO or authorisation by PAO. (Department of Pension & Pensioners' Welfare's OM No. 1/11/2020-P&PW (E). dated 29th July, 2020)
- Separately, process the case for family pension and death gratuity in Bhavishya and forward the case to PAO in Form 18 along with other documents for further processing/authorisation. (Rule 80)
- Government dues such as HBA, licence fee, etc. are to be recovered from death gratuity.

#### B. Death Gratuity:

# Length of qualifying service

- (i) Less than 1 year
- (ii) One year or more but less than 5 years
- (iii) 5 years or more but less than 11 years
- (iv) 11 years or more but less than 20 years
- (v) 20 years or more

#### Rate of death gratuity

2 times of emoluments.

6 times of emoluments.

12 times of emoluments.

20 times of emoluments

Half of emoluments for every completed six-monthly period of qualifying service subject to a maximum of 33 times of emoluments.

Maximum amount of death gratuity: Rs 20 lakh.

#### Eligibility:

- Gratuity is to be paid to the family member(s)/person(s) in whose favour a valid nomination exists. If there are more than one nominee, amount of gratuity shall be shared by all nominees as specified in the nomination.
- If a nominee has pre-deceased the Government servant, then the gratuity is to be paid to the alternate nominee(s), if any, mentioned in the nomination form.
- If there is no nomination or the nomination made does not subsist, the amount of gratuity is to be equally shared among spouse, son(s), unmarried daughter(s) and widowed daughter(s).
- If none of these family members is available, the amount of gratuity is to be equally divided among other family members, i.e. father, mother, married daughters, brothers below 18 years, unmarried/widowed sisters and children of a pre-deceased son.
- Succession certificate is not to be asked for unless there is no valid nomination and also none of the family members mentioned above is available.

Documents required to be submitted by the claimant for gratuity: (i) Application in Form 12, (ii) Death certificate, (iii) copy of PAN card, (iv)copy of first page of bank pass book and (v) proof of relationship.

### Action By HOO:

- Process the case for death gratuity (along with family pension) in Bhavishya and forward the case to PAO in Form 18 along with other documents for further processing/authorisation.
- Sanction provisional death gratuity in accordance with Rule 80-A, after forwarding the case to PAO

### C. Cash equivalent of leave salary (Leave Encashment)

As per Rule 39-A of CCS (Leave) Rules, 1972, cash equivalent of leave salary for earned leave not exceeding 300 days is payable to the family. If the earned leave in the credit of the deceased Government servant is less than 300 days, half pay leave is encashed to the extent the earned leave is short of 300 days.

Eligibility: One of the available family members in this order -> Spouse, eldest surviving son, eldest surviving unmarried daughter, eldest surviving widowed daughter, father/mother, eldest surviving married daughter, eldest surviving brother below the age of eighteen years, eldest surviving unmarried sister, eldest surviving widowed sister; eldest child of the eldest predeceased son.

Leave encashment is processed/sanctioned by HOO on receipt of death certificate without seeking any application for this purpose.

#### D. Central Government Employees Group Insurance Scheme (CGEGIS)

Amount: In addition to the amount standing in the Savings Fund of CGEGIS, an amount of RS, 1,20,000, Rs. 60,000/- and Rs. 30000/- is paid to the family of the deceased employee belonging to Group A, Group B and Group C, respectively.

#### Eligibility of family members:

- CGEGIS amount is payable to family member(s)/person(s) in whose favour a valid nomination
  exists.
- In the absence of a nomination, the amount is paid to the family members eligible as per the rules applicable for payment of death gratuity.
- The claim for CGEGIS is processed/sanctioned on receipt of death certificate without seeking any application for this purpose.

### E. General Provident Fund (GPF)

- On receipt of the death certificate, the balance in the GPF account of the deceased Government is sanctioned to the family member(s)/person(s) in whose favour a valid nomination exists. In the absence of a nomination, GPF balance is paid to the family members eligible as per GPF Rules.
- As per the Deposit Linked Insurance Scheme under Rule 33-B of the GPF Rules, in addition to
  the GPF balance, an additional amount equal to the average balance in the GPF account during
  the 3 years immediately, preceding the death of the Government is also paid, subject to the
  conditions that the balance at the credit did not, at any time during the three years preceding the
  month of death, fall below the limits mentioned in Rule 33-B.
- The additional amount to be paid shall not exceed Rs 60,000/-.
- The claims for GPF/DLIS are to be processed anctioned by the office on receipt of death certificate.

- (1) Entitlements of family on death of a Government servant under National Pension
  System who had opted for benefits under Old Pension Scheme or in whose case, no
  option was exercised and the default option is Old Pension Scheme
  - Family Pension: Same as under Old Pension Scheme.

In addition, employee's contributions and returns thereon in the NPS pension Corpus shall also be paid to the family member. HOO will start process to sanction family pension and simultaneously close PRAN under NPS and Government contribution (and returns thereon) would be transferred into the Government account. Remaining amount would be paid in lump sum to the nominee or legal heir as per PFRDA regulations.

- <u>Death Gratuity</u>: Same as under Old Pension Scheme
- Cash equivalent of leave salary (Leave Encashment): Same as under Old Pension Scheme
- <u>Central Government Employees Group Insurance Scheme (CGEGIS)</u>: Same as under Old Pension Scheme

The evaluator to be decided by competent authority (General Manager of the Zonal Railway or any Head of Department to whom the power is delegated by the General Manager) shall liase with ECA/evaluating agency and ensure the preparation of results after verification/sample checks of answer sheets. He will be responsible for preparation of unit-wise merit-list."

The three-member committee at Division/Unit level including at least 1 officer from the department for which selection is being held and one Personnel officer, shall be nominated for finalizing the panel as only the written exam of the selection/LDCE/General Selection is centralized while the panel formation is still at the level of seniority unit. One of the 3 committee members will be from the reserved communities i.e. Scheduled caste or Scheduled Tribe."

The undersigned is directed to refer to Ministry of Railways OM No. E(NG)1/2019/PM4/8 dated 05.04.2023 regarding the above cited subject seeking comments on Para 8.1 & 8.2 of DoPT OM No. 36012/01/2020-Estt. (Res-II) dated 17.05.2022.

- In this regard, it is informed that so far as the issue of promotion on 'selection' basis is concerned, the basic standard for selection, as prescribed through the OM No. 35034/7/97-Estt(D) dated 08.02.2002, is the Benchmark Grading in APARs.
- 3. In case of Limited Departmental Examination/Departmental Examination, minimum qualifying marks for PwBDs may be decided by the Administrative Ministry/Department in consultation with the Recruiting Agency conducting the examination. Therefore, the issue of extent of such relaxation for PwBDs would mean a lower cut-off marks to qualify and that could vary from post to post depending upon the minimum qualifying marks specified for the examination and the cut-off marks arrived at based upon the number of vacancies to be filled up though this examination. Accordingly, the extent of relaxation may vary from case to case.
- If any extent of relaxation has been decided for a particular Limited Examination/Departmental Examination in Departmental candidates belonging to SC/ST category, where sufficient number of candidates belonging to SC/ST categories (as per vacancies earmarked for these categories) do not qualify the examination in the normal course, same extent of relaxation can be extended to candidates belonging to to those PwBD category, who do not belong to SC/ST category. The Hon'ble Court of Chief Commissioner for Persons With Disabilities in case no 13604/1022/2022/R37714 regarding provisions relating to transfer of PwD employees has desired that suitable instructions be issued to all concerned for strict compliance of provisions relating to transfer of PwD employees. In this regard, attention is invited to instructions issued by the Railway Board from time to time for helping disabled Non-Gazetted employees working on Zonal Railways.

- 2. Attention in this connection is invited to instructions contained in Board's letter No. E(NG)I-91/TR/13 dated 11.02.1992, vide which DOP&T's OM dated 10.05.1990 were circulated for adoption wherein it was provided that candidates recruited on regional basis and who are physically handicapped may be given posting as far as possible, subject to administrative constraints, near their native places within the region. Extant instructions also provide that requests from PwD employees for transfer to or near their native places may also be given preference
- 3. Further, vide Board's letter No E(NG)I-2015/TR/20 dated 10.02,2017, physically handicapped Railway servants have been exempted from the condition of minimum of five years service required for inter railway transfer requests.
- 4. Apart from the above, attention in this regard is also drawn to Board's letter No E(NG)I/2014/TR/12 dated 01.08.2014 and E(NG)I-2019/TR/1 dated 30.01.2019 adopting instructions contained in DoP&T's OMs No. 42011/3/2014-Estt(Res) dated 6.6,2014 and No F. No. 42011/3/2014-Estt.(Res) dated 08,10,2018 respectively, providing that government employees who serve as main care giver of dependent daughter/ son/ parents/ spouse/ brother/ sister with specified disability may be exempted from exercise of routine transfer.

5. Ministry of Railways desire that extant instructions on the subject as referred to in the preceding paras may be followed scrupulously. The aforementioned instructions are hereby reiterated for strict compliance.

The Task Force (Vigilance) has made the following the ton: recommendation: rotection from transfers being given to the officials of the TRADE UNIONS should be restricted to only one or two main functionaries of the Trade Union Viz. President/Vice President and/ or General Secretary/Organising Secretary. The Ministry of Railways have carefully considered the matter and they desire that the instructions issued on the subject from time to time as brought out in the note attached may be strictly followed in dealing with the cases of transfer of recognised Trade Union office bearers. The receipt of this letter may be acknowledged. (A.K.F. UNNY) DA: Ma above. Direntor, Establishment(L) Railway Roard.

#### Sub: Transfer of Recognised Trade Union Office bearers - Procedure to be followed.

any proposal for transfer of an office bearer of a recognised Trade Union including the Branches there-of should be communicated by the Railway to the Union concerned and the Union allowed to bring to the notice of the Divisional Officer and, if necessary, later to the General Manager any objection that they may have against the proposed transfer. If there is no agreement at the lower levels, the decision of the General Manager would be final. Sufficient notice should be given to the Union of a proposed transfer so that the Union can make alternative arrangements for carrying on work or making a representation against the proposed transfer. ( Railway Board's letter No.E(L)60UI1-31 dated 19.2.60)

- In the cases of usual periodical transfer, however, where is decided after consideration of the appeal by the Ceneral Manager not to cancel the transfer, the transfer may be allowed to pend till the next election of the Union Office bearers subject to a maximum period of one year. This will not apply to transfers on special considerations ordered in public interest (Board's letter No.E(L)61PE1/43 dated 31.7.61)
- In case of an employee who is transferred at his own request there is no need to follow the usual procedure. It is for the employee himself to satisfy the Union to which he belongs 10( (E(L)64UT1-113 dof 6.10.64).
  - In regard to transfer of an employee to comply with statutory obligations under the Hours of Emphoyment Regulations, the Railway Administration should comply with the procedure by conveniently planning the transfers. (E(i)64UT1-113 of 6.10.64).
- In case of an employee being transferred on promotion the Union need only be informed about the proposed transfer and it is not necessary to pend the same unless the employee wishes to refuse promotion. A senior employee need not be transferred in preference to the one promoted in order to ancommodate a Trade Union Orfice bearer on promotion at that station staelf unless ... i loc! of 6.10.64).

6. Transfer of an employee having been rendered surplus at a particular station should be treated in the same way as in para 10 C 5 above. (E(L)64UT1-113 of 6:10.64).

- 7.2 The procedure need not be followed in a case where the trensfer of a Kailway Employee is considered necessary by the SPE/Vig. Organisations of the Railway. In such a case papers should be seen by the General Manager personally before the transfer is decided. The trade union is also advised of the transfer but it is not necessary to give any notice for this purpose. Similarly, in a case where the civil and police authorities have recommended immediate transfer of a railway employee who is an office bearer of a recognised Union on the ground that he was indulging in undesirable activities and thereby affecting efficient functioning of the Railway, there is no objection to deviation from the normal procedure (E(LR)75UT1-176 dated 8.8.75).
- 8. In case of transfers from one section/department to another in the same office, there is no need to give notice to the Union beforehand. However, the union may be informed about the transfer at the time of effecting such transfers. In the case of transfers to another office located at a distance but within the same area at the same station, usual procedure may be followed. (E(I)64UT1-113 dated 21.1.64).
- 9. The usual procedure is to be followed for transfers from one Administratives jurisdiction to another (for example, workshop establishment to a loco shed) at the same station.

The circumstances under which a resignation submitted by a Govt./Railway employee is to be treated as 'Technical Resignation' have been amply clarified in DoP&T's OM, dated 17/08/2016 implemented mutatis-mutandis in the Railways vide RBE No. 21/2017 circulated under this office serial no.26/2017. Chapter-XIV of IREM, Vol.I (revised edition-1989, re-print 2009) also provides various provisions on the subject.

- 2. A careful reading of the aforesaid guidelines/provisions revealed that the provision of technical resignation would carry the benefit of past service for the purpose of various service benefits, if otherwise admissible under relevant rules. Hence, it is incumbent on the Appointing Authority to verify the fact whether the concerned employee who has tendered the resignation for joining the same or other department/office is actually qualified for counting the past service for the purpose of reckoning the various service benefits before treating it as 'Technical Resignation' in each case. To make it more amplify, the employee on probation and thereby not holding a lien of a post, is not entitled to the benefit of counting the past service for the purpose of retention of lien in the parent department for a period of 2 years or 3 years (in exceptional cases). So, in the event of accepting technical resignation in such situation it would cast the responsibility of the parent department to retain the lien of the post even though the same is not admissible under the relevant rule regulating such benefit. Similarly, the benefits of protection of presumptive pay of the previous post, carry forward of unutilised leave under Leave Rules, Joining time pay, Transfer Travelling Allowance and Pensionary benefits can be extended in such situation counting the past service, only if the employee concerned is a permanent employee and thereby holding a lien of the post. Thus, while resignation of the employee who is still on probation may be accepted in such situation, but it cannot be connote as technical resignation.
- 3. Further, in accordance with the provision of Para 103(iv) of Chapter-I, Section-B, Sub-Section-I of IREM, Vol.I ibid, a 'Trainee' means a person undergoing training with a view to employment in railway service, who draws pay, leave salary, subsistence allowance or stipend during such training but is not employed in or against a substantive vacancy in the cadre of a branch or department. As a sequel of this provision, the question of 'Technical Resignation' in the given situation does not arise. However, there is no bar to accept resignation in such case, subject to provision under Para 1410 of IREM, Vol.I.

This issues with the approval of competent authority.
