This is in continuation to this office earlier letters of even no. on the issue.


Railway Board, vide their letter No.AE/A3/2024/1/2 dated 02.05.2024, have now intimated that **Admit card** containing the details of the candidate, exam city and roll no. along with other details, as earlier sent to Board based on the data received from the units, *is now available for downloading*. Candidates under your respective control should be advised to download their respective admit card from the link <https://rb.cbtexam.in/>.

2. Along with their letter *ibid*, Board have also enclosed Model Question paper I (GRP, Establishment, PF, Pension/NPS, Labor Laws, Expenditure, Associated Finance, Books and Budget and Book Keeping), Model Question paper II (Stores, workshop, COS procedure, workshop costing and associated finance, Expenditure & WMS & Stores account), Model Question paper III (Traffic Accounts, Finance, Traffic Statistics/Costing, Station Accounts and Inspection) and Model Subjective Paper. The model papers as above are accessible at and can be downloaded from https://indianrailways.gov.in/railwayboard/uploads/directorate/accounts/downloads/compendium_2024/SAMPLE%PAPER%20SET%201.pdf. *Units/Metro Railway are requested to give wide publicity of these Model papers amongst the candidates in order to acquaint them with the new pattern of Appendix III-A examination.*

3. In the above context, please connect this office earlier letter of even no. dated 25.04.2024 whereby certain details regarding PwBD as well as PwD candidates were called for and received from responding unit offices/ Metro Railway. According to the same, there are a total of **15 nos.** of PwBD candidates [with **not** less than 40% of a specified disability – as per Section 2 (r) *ibid*] and **NIL** PwD candidates [with less than 40% of a specified disability – as per Section 2 (s) *ibid*]. The above information will be made use of while sending feedback in the matter to Board unless *updated position, if any*, is received from *the units*/Metro Railway **latest by 13.05.2024**.

It is mandatory for all the units to keep record of medical certificate of each PWD candidate as per prescribed format.

4. As advised by Board, it is requested that the information regarding extant provisions for PwBD candidates, particularly Ministry of Social Justice and Empowerment's OM No.34-02/2015-DD-III dated 29.08.2018 and RBE No.162/2022 and other policy guidelines issued on this subject from time to time, may be widely disseminated.
