1. Eligibility and Service conditions of staff:

I. (A)Matriculation/SSLC plus ITI from recognized institutions of NCVT/SCVT in the trade of Armature and Coil Winder/ Electrician /Electronics Mechanic/ Fitter/ Heat Engine/ Instrument Mechanic/ Machinist/Mechanic Diesel/ Mechanic Motor Vehicle/Millwright Maintenance Mechanic/Mechanic Radio &TV/ Refrigeration and Air Conditioning Mechanic/ Tractor Mechanic/Turner/Wireman.

OR

Matriculation/SSLC plus Course Completed Act Apprenticeship in the Trade mentioned above.

OR

(B) Matriculation/SSLC plus three years Diploma in Mechanical / Electrical / Electronics / Automobile Engineering.

OR

Combination of various streams of these Engineering disciplines from a recognized University/Institution in lieu of ITI.

NOTE: Degree in the Engineering disciplines as above will also be acceptable in lieu of Diploma in Engineering.

II. Age Limit: -The upper age limit will be 42 years for UR candidates and 47 years for SC/ST candidates. The age will be reckoned as on the date of notification.

III. Medical Standard: -

They should be fit in the appropriate medical standards i.e., AYE ONE (A-1), prescribed for appointment to the post of Assistant Loco Pilot in Level – 2 of 7^{th} CPC Pay Matrix.

IV. It should also be noted that employees, otherwise eligible to appear in the examination are eligible <u>ONLY</u> for the units they belong to and as such, should only apply to.

2. Notifying to the staff:

The controlling officer/supervisor shall give wide publicity of the notification to all the eligible staffs under their control, and notification should be displayed at conspicuous place. It is the responsibility of controlling officer/supervisor to circulate the notification among the staff concerned. The concerned supervisory officials should ensure the relief of SC/ST employees so that they may be imparted the pre-selection coaching for about 3 to 4 weeks as required under the rules.

3. FILLING UP OF APPLICATION FORM:-

3.1. How to apply:

Regular Railway Employees who fulfill the above eligibility conditions may submit the application in the prescribed proforma, which is enclosed as Annexure – A, along with attested copy of the Educational Qualification Certificates (from Matriculation/SSLC onwards) to concerned supervisory officials on or before 12.06.2024.

3.2. Last date for submission of Applications:

- a. Supervisors concerned are advised to collect all applications in response to this notification and forward the same to their controlling Officer on or before 12.06.2024.
- b. Controlling officers are advised to collect all applications in response to this notification and forward the same to Personnel dept. of their division on or before **20.06.2024**. Personnel dept of divisions/workshops are advised to send the list of eligible staff to APO/Coordination/HQ by **03.07.2024** in hard copy as well as in MS Excel format as communicated to Unit. While finalizing the list of eligible staff, Units may keep in view the instructions contained in RBE No. 196/2019.
- c. Any application received after the last date, i.e. **12.06.2024** and application received other than in the prescribed proforma will not be entertained and will be rejected without any notice.

3.3. Staff should note the following: -

- a. Format of application form is provided with this notification as Annexure-A.
- b. Filled up application should be submitted by staff with affixing recent front facing colour photographs (3.0 cm.x3.5 cm.) without cap.
- c. It should be ensured by the staff concerned that in the service record the community of the staff should be recorded as claimed by the staff concern as SC or ST.
- d. Staff should very carefully go through the notification and fill up the application form with correct information and should note that information provided in the application cannot be changed after submission of the application to the controlling officer of the unit where the staff is working.

4.MODE OF SELECTION, EMPANELMENT AND QUALIFIYING MARKS:

- 4.1. The Computer Based Test (CBT) which shall be of standard of RRB consisting 100% objective type (multiple choices) consisting of 110 questions (including 10 questions on Official Language Rule) for the post of Apprentice/Trainee Assistant Loco Pilot. Candidate will be tested in the technical subject also. Employees are required to answer any 100 questions.
- 4.2. The duration of the examination will be 120 minutes.
- 4.3. Employees may note that there shall be negative marking for each incorrect answer as the panel will be drawn on merit. One-third (1/3) of the marks allotted for each question will be deducted for wrong answers (RBE No.194/2019)



- 4.4. The candidates will have the option to answer questions either in English or Hindi.
- 4.5. The selection will be finalized entirely on Merit as per the instructions contained in RBE No. 113/2009, dt. 19.06.2009.
- 4.6. The qualifying marks for safety categories including the Running staff should be 60% i.e. staff must acquire 60% in written to qualify the exam and with no relaxation for SC/ST. {Authority: Master Circular-31 circulated vide Rly. Bd.No.E(NG)I/2019/PM1/20 dated 19.12.2019 para 8 Allotment of marks Note (b)}

5. Computer Based Aptitude Test (CBAT)

CBT qualified staff will have to appear Aptitude test / Psychometric test and qualify the 5.1 same as per prescribed standard as per extant rules by respective units.
