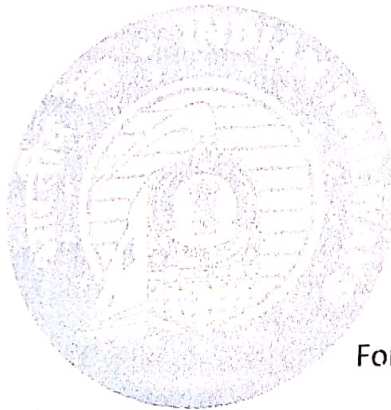



2. Now, on consideration of the requests/demand received from SECR, SWR, WCR, ECoR, NER, ECR, MCF, CLW and RCF, the Full Board in the exercise of the powers vested in it to make reasonable relaxations in public interest for a class/group of employees in all or any of the provisions regarding house allotment/retention, have decided that SAG & above level officers posted in SECR, SWR, WCR, ECoR & NER and all officers/staff posted in ECR, MCF & CLW may be permitted to retain Railway accommodation at their previous place of posting for a further period of one year beyond 31.03.2024 i.e. up to 31.03.2025 subject to the conditions stipulated in Board's letter dated 01.07.2022.

3. Further, full Board have also decided that SAG & above level officers posted at RCF/Kapurthala may be permitted to retain their Railway accommodation at their previous place of posting from 01.05.2024 to 31.03.2025 subject to the conditions stipulated in Board's letter dated 01.07.2022.
