
1. The Terms of Reference (ToR) of the work shall be primarily as under :-
  - (i) The retired officers re-engagement as Consultants shall perform all the jobs related to the post as assigned by the concerned Railway Controlling Officer as provisionally outlined in the Annexure & will be posted or placed under Gati Shakti Unit/Asansol/ER and the re-engaged officer should be ready to carry out the same.
  - (ii) The posting and duties of the re-engaged officers are liable to change as per departmental requirement.
  - (iii) Re-engaged officers shall not be in independent charge / head and will not be given the financial and DAR powers and shall not be authorized to issue safety certificate but would be required to handle responsibilities like inspections, supervision, drawing etc.

2. **Terms and Conditions :-**

- (i) General Managers are empowered to re-engage retired Officers.
- (ii) Suitability/competence of the retired officer shall be adjudged before such re-engagement by a committee and the decision of the committee will be final.
- (iii) Removed / Dismissed/ compulsorily and voluntarily retired officers are not eligible for re-engagement.
- (iv) The re-engagement of officers is subject to obtaining of prescribed medical fitness of the appropriate category shall be obtained from the designated authorities as per existing practices.
- (v) The period of engagement shall be initially for one year and further extendable as per administrative requirement.
- (vi) Maximum age limit of the re-engagement shall be 65 years. No re- engaged employee should continue in service beyond 65 years of age.
- (vii) The re-engagement of consultant shall not be considered as a case of re-employment.
- (viii) 12 days leave in a calendar year on pro rata basis is admissible.
- (ix) Re-engaged officers shall not be entitled for requisites such as HRA, CCA, Transport Allowances, Residential accommodation etc.  
However, when required to travel in connection with official work, TA/DA admissible to regular employee working in the same Grade will be admissible.
- (x) The designation shall be consultant followed by (trade name) i.e. Officer appointed against the post of ADEN may be designated as Consultant (Engg.)
- (xi) Re-engaged officer shall be given the responsibilities like inspections, supervisions, drawing etc.
- (xii) Re-engaged officer shall not be made in charge of the unit like Branch Officer in the Division or independent in charge in the Construction unit.
- (xiii) Re-engaged officer shall not be given the financial and D&AR powers and shall not be authorized to issue any safety certificate.
- (xiv) The consultant shall not divulge any information gathered by him / her the period of assignment related to the organization to anyone who is not authorized to know / have the same.

- (xv) Re-engaged officers shall be discharged immediately on joining of selected candidate(s) from UPSC or departmental selection or as per the recommendation of the convened Railway Controlling Officer.
- (xvi) Re-engaged officer may be terminated within the period of one year on performance / behavior related grounds after giving him / her a notice in this regard within seven (07) days' time to respond and after considering his / her representation thereto by the concerned Head of the Unit.
- (xvii) Re-engaged officers may submit his / her option if he / she is not willing to perform duty and continue as Consultant. A notice in this regard may be submitted to controlling officer before (07) days of relinquishment of the charge of the post.
- (xviii) Monthly remuneration of a retired officer being re-engaged will be determined as stipulated in Rly. Board's letter No.E(NG)/2007/RC-4/CORE/I dated.24/01/2019.
- (xix) The duty hours of there the Re-engaged employees would be 08 (eight) hours per day. (Per field inspection TA etc. to be admissible for extra hours).
