



Sub: Recruitment of staff in Level - 1 of 7th CPC Pay Matrix on Indian Railways - modifications of criteria of Physical Efficiency Test (PET) for Ex-servicemen and Pregnant female candidates regarding.

Modifications of criteria of Physical Efficiency Test (PET) for Ex-servicemen and Pregnant female candidates was under consideration of Board and it has now been decided to provide following relaxations to Ex-servicemen and pregnant female candidates in PET for recruitment to Level-1 posts:

- i. **Ex-Servicemen:** Ex-Servicemen will be exempted from Physical Efficiency Test. However, all Ex-Servicemen will be required to pass the written test, physical standards, if any and medical standards of the post as prescribed for direct recruits.
- ii. **Pregnant Female Candidates:** On reporting of female candidates for PET (Physical Efficiency Test), a self-declaration indicating about her pregnancy status shall be submitted by her. In case she declares that she is not pregnant then she may be allowed to participate in the PET. In case of false declaration, all the risk of undergoing PET will be of her own. If the female candidate declares before PET that she is pregnant, then a confirmatory pregnancy test shall be done and in case she is found to be pregnant, irrespective of duration of pregnancy, she shall be declared temporarily unfit and her appointment shall be held in abeyance until the confinement is over. The vacancy against which the woman candidate was selected would be kept reserved for her. She would be re-examined for PET six weeks after the date of confinement, subject to production of medical certificate of fitness from a registered medical practitioner. If she is found fit in PET & ME, she may be appointed to the post kept reserved for her and allowed the benefit of seniority in accordance with the rules / instructions of the Railway Board as amended from time to time. In case a female candidate after confirmatory pregnancy test is not found pregnant, she will be allowed to participate in PET.

2. The above relaxations shall be applicable in all future notifications for direct recruitments to Level-1 posts.



Consequent to implementation of recommendations of 7th CPC, as accepted by Government of India, orders regarding revision of rates and ceilings of Tenure Allowance to Officers of Organized Group 'A' Services on their appointment as Deputy Directors/ Joint Directors/ Directors in the office of RDSO and Railway Board were issued vide Board's orders bearing RBE No. 181/2017 and 182/2017 respectively.

2. Now, with the enhancement of Dearness Allowance to 50% of Basic Pay, the ceilings of tenure Allowance may be revised upwards by 25% to Rs. 11,250 per month with effect from 1st January, 2024.

3. All other conditions stipulated in RBE No. 181/2017 and 182/2017 shall continue to hold valid.
