

In continuation to this office letter of even number dated 06.08.2024, it is stated that the candidates, as listed at enclosed Annexure-I, have come out successful in the subject CBT, conducted by NAIR on **04.08.2024** and results published vide letter under reference. The names of the candidates in the above list are *not* in order of marks obtained.

The said candidates may please be informed that they should be in readiness to be called for viva-voce test for the subject selection i.e. 30% (LDCE) to be held shortly. The schedule and venue of the viva-voce test will be informed subsequently.

2. In terms of Para 206.2 of IREM (Vol.I, 1989 Ed.), Group-C employees qualifying in the selection for promotion to Group-B posts would be required to pass the prescribed medical standard. Only those who qualify in the medical examination of prescribed standard shall be called for viva-voce. It may please be ensured that all the above-mentioned candidates under your control are sent for the prescribed Medical Examination and the Medical Reports of the candidates are sent to **CAO/Admn (Secret/Confdl Cell)** by **17.09.2024, positively**.

3. The **service records**, complete in all respects, of the concerned candidates under your control should be forwarded to **CAO/Admn (Secret/Confdl Cell)** by **13.09.2024, positively** under sealed cover through special messenger. It is presumed that APARs for the years **2017-18, 2018-19, 2019-20, 2020-21** and **2021-22** in respect of candidates have already been made available to Secy. to PFA as per earlier advices. If not, the same should be done immediately.


4. Whether there is any D&AR case pending against the candidates mentioned in the list *ibid* should also be indicated separately and sent to **AFA/Admn** in a sealed cover by the above-mentioned date. While forwarding the said D&AR clearance, it may also be invariably indicated **whether any of them is under Suspension, or any Departmental proceedings have been initiated by issue of a Charge-Sheet or the Railway Servant is facing any prosecution.**

Further, it is also requested to obtain **declaration on pendency of criminal case**, if any, from the concerned candidate as per the proforma prescribed in terms of CPO/ER's letter No.E/GAZ/Misc/Policy Dated 01.09.2017 (copy enclosed) and arrange to forward the same to **AFA/Admn** by the above-mentioned date for further action at this end.

5. Please confirm by return post positively that all the candidates under your control have been duly intimated of the contents of this letter.
