1. Promotion of staff is provisional and subject to the disposal of the case in Civil Misc. Petition No. 1401/1404 of 1979 and Writ Petition No.(Civil) No. 1401/1044 of 1979.
2. Staff under order of promotion should be released immediately and should not be detained on administrative ground and it would be the responsibility of the controlling officer to relieve the staff.
3. Provision of CPO/ER's Sl. No. 86/2017 is applicable. Option for fixation of pay in the higher grades on the date of next date of increment in the substantive grade. If the promote so desires, should be submitted by him/her to his/her office within one month from the date of issue of this order.
4. If the staff under order of promotion is unwilling to accept the same an unconditional written declaration foregoing promotion may kindly be obtained from him and sent to this office within 10 days from the date of issue of this order. His/her next turn for promotion will be regularized as per extant rules.
5. In case staff having Railway quarter is not vacating on transfer, necessary damage rent will be charged for unauthorized retention as per extant rules.

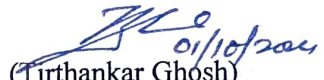
