CONSTITUTION OF COMMITTEE MEMBERS AS BROUGHT OUT IN RULE 7 (4) & (5)
UNDER CHAPTER-VI OF PUBLIC EXAMINATIONS (PREVENTION OF UNFAIR
MEANS) RULES, 2024.

1. **RULE 7(4):** The cases referred in sub-rule (3) shall be referred to a committee to be constituted by the public examination authority which shall examine the report of the Regional Officer and submit its findings to the public examination authority for appropriate decision.
2. **RULE 7(5):** The committee referred to in sub-rule (4), shall comprise of a senior official from the public examination authority, an expert member to be nominated by the public examination authority and a member from the Ministry or Department (not below the rank of Director) to which the public examination authority reports.

- (i) The committee shall normally be as per 1st arrangement. The whole composition of committee (1st arrangement) shall not be changed in case of non-availability of any one member. Officer from 2nd arrangement shall replace only that official who is not available in the 1st arrangement. PCPO of the Zonal Railways/PUs in consultation with Chairman of the jurisdictional RRB shall decide & communicate approval for formation of the committee to RRB/RRCB/Public Examination Authority.
- (ii) The Report of the Committee under Para 7(5) shall be submitted through Chairman of Jurisdictional RRB, Nodal RRB (CEN Exam) & Principal Nodal RRB (RRB that has engaged ECA) to Railway Board for acceptance and further instructions.

**CONSTITUTION OF COMMITTEE MEMBERS AS BROUGHT OUT IN RULE 8(2)
UNDER CHAPTER-VII OF PUBLIC EXAMINATIONS (PREVENTION OF UNFAIR
MEANS) RULES, 2024.**

1. **RULE 8 (2):**A committee may be constituted by the public examination authority which shall be headed by an officer not below the rank of Joint Secretary or equivalent and shall comprise of one senior officer from the public examination authority and an expert to be nominated by the public examination authority.

Note: Above mentioned committee shall be formed to investigate the matter for deciding filing of FIR/Administrative Action or otherwise in case there is involvement of "Public Servant".

- (i) The committee shall normally be as per 1st arrangement. The whole composition of committee (1st arrangement) shall not be changed in case of non-availability of anyone member. Officer from 2nd arrangement shall replace only that official who is not available in the 1st arrangement. **PCPO of the Zonal Railway in consultation with Chairman of the jurisdictional RRB shall decide & communicate approval for formation of the committee to RRB/RRCB.**
- (ii) The Report of the Committee under Para 8(2) shall be submitted through Chairman RRB of Jurisdictional RRB to GM (for Gaz. employee) /DRM (for Non-Gaz.employee) of that Zonal Railway to which administrative control of "Public Servant" belongs, for acceptance & further instructions.
