"In view of the above, with all other eligibility norms for recruitment of sportspersons in Cricket (Men & Women) game discipline as mentioned in para 4.1 (i) to (iv) of Board's letter No. 2010/E(Sports)/4(1)/1(Policy) dated 31.12.2010 alongwith subsequent amendments issued thereto remaining unchanged, it has been decided to revise the norms for recruitment of sportspersons in Indian Railways against sports quota in the game discipline of Cricket (Men & Women) in supersession of instructions issued vide para 4.1 (d), (e) & (f) of Railway Board's letter No. 2018/E(Sports)/4(1)/14 dated 13.08.2019 as under:-"
