- 3. Applications are invited from the following categories of staff of KPA Workshop/Eastern Railway to fill up of the above mentioned post of Jr.Clerk cum Typist in Level-2:
 - i. General Assistant and other office staff in Level-1 or with substantive GP Rs.1800/- of all Departments.
 - ii. Safaiwala, Chowkidar in Level-1 or with substantive GP Rs.1800/- of all Departments.
 - iii. Workshop Assistant in Level-1 or with substantive GP Rs.1800/- of all Departments.
 - iv. Hospital Attendant in Level-1 or with substantive GP Rs. 1800/- of Medical Department.

4. Eligibility Criteria:

- i. Erstwhile Group-D staff belongs to the categories mentioned at (i) to (iv) of Sl.No.3 above are eligible for apply.
- ii. Such regular employees of Level-1 who are appointed on or before 17-12-2014 must have passed the Matriculation Examination or equivalent from recognized institute.
- iii. Such regular employees of Level-1 who are appointed on or after 18-12-2014 must have passed 12th (+2 Stage) or its equivalent examination with not less than 50% marks in the aggregate.
 - However, 50% marks in aggregate is not mandatory for SC/ST/Ex-Servicemen Employees (RBE-157/2015). Further not less than 50% marks will not be insisted upon in case of those candidates who posses qualification higher than 12th (+2 Stage) in terms of RBE-62/2020.
- iv. All the above said employees who want to apply should have completed Two years continuous service from the date of regularization as on 15-10-2024.
- v. The service rendered in the old unit of the employee who joined this workshop on own request transfer shall be reckoned subject to the condition that the service so allowed to be counted does not exceed the length of service of their immediate senior in the new unit as per RBE No. 34/2006.
- vi. Any staff in Level-1 or with substantive GP Rs.1800/-, even though they may be enjoying higher GP under ACP/MACP Scheme, can submit their application for the said post. The fixation of pay of such upgraded staff, on promotion to the post of Junior Clerk, will be done as per PCPO/ER/Kolkata's SI. No.102/09.

- 5. The selection will consist of written test Record verification. The applicants must have the knowledge in English & Hindi. According to Rly. Board's Letter no. E(NG)I-96/CPP/19 Dtd. 03-02-1997, the employees who find place on the panel will have to qualify in the prescribed typewriting test 30 W.P.M. in English or 25 W.P.M. in Hindi in three attempts within two years from the date of promotion on Type Writers, the same will be tested on Personal Computer and If they fail to qualify in the typewriting test, they will not be reverted but their increment, confirmation as Junior Clerk, further promotions etc will be regulated in terms of RBE-09/2023.
- 6. The Question paper will be set in Hindi & English only. The written test will be of 2 hours Consisting 100% objective type questions, all the questions will be of Multiple Choice only in terms of RBE-196/2018. There shall be negative marking for incorrect answers. One third of the marks allotted for each question will be deducted for wrong answers. Cutting, over writing more than one answer, erasing, whitening or alteration at any type in the answer sheet will not be accepted, Zero marks will be given for having correction/overwriting and multiple marking.
- 7. This Written examination will be held to test the working knowledge of the railway employee of the English language and the general standard of intelligence and proficiency through question in Arithmetic, General Knowledge mainly pertaining to Railway matters and matters immediately pertain to the work employees have been acquainted with during their railway service. 10% of total marks on official language will also be a part of written test for this selection.
- 8. Candidates who secure minimum 60% marks under the head "Professional Ability" (in the written examination) will be considered for assessment of "Record of Service" against general vacancies (PCPO/ER's SI.No.128/2009). However, this is subject to usual relaxation for SC/ST employees, wherein the minimum pass marks at this stage is 50% under the head "Professional Ability" for reserved vacancies(PCPO/ER's SI.No.217/1999).
- 9. The panel will be prepared as per Railway Board's Letter No.E(NG)I-2011/PM-1/26 dtd.06-02-2014 (RBE-17/2014).
- 10. As per PCPO/ER/Kolkata's SI. No. 121(10)/2003, the aim of the written test is "to assess the general suitability of the candidates offering themselves for promotion to Gr.-'C' posts from the point of view of their knowledge of English and their general standard of intelligence. The factors of the selection and their relative weight are indicated below.

- 11. In terms of PCPO/ER/Kolkata's SI. No. 217/99 Para-6.1 Pre-selection/Pre-promotional Training should be given for safety categories for candidates belonging to SC/ST Communities. Since the selection for the post of Jr.Clerk is for non-safety category, Pre-selection/Pre-promotional training is not necessary.
- 12. Supplementary Test may be held only in the absence caused by unavoidable circumstances due to the reason mentioned in Para 223 of IREM Vol.-I.

- 13. Since the promotion through LDCE are purely on the basis of merit and there is already a provision of relaxing in qualifying standard for SCs/STs for filling up reserved vacancies, policy of best amongst the failure scheme in promotions through LDCE will not be applicable in terms of PCPO/ER's SI.No.62/2021.
- 14. Application in Pro-forma given at Annexure-A, duly filled in candidate's own hand writing, should be submitted to the concerned Branch Officer by 05-11-2024. Application received after the cutoff date, i.e. 05-11-2024 will not be entertained under any circumstance and should not be forwarded.
