4 b) (i) Particulars of Organization, Functions and Duties

The Mechanical C&W Department has contributions in the following fields:

- There are 06 depots under Sealdah Division handling both Coaching and Wagon activities:
- 1. SEALDAH It is a mega coaching depot maintaining total Twenty Seven (27) Mail/Express/Passenger trains, out of which 25 Nos. Primary Maintenance trains and 02 Nos. Round Trip Maintenance Trains. It also consists of 01 Mechanized Laundry capacity of 6.5 Tons per shift. 01 Bio-Toilet Effluent Testing Laboratory is also available. Under floor wheel lathe is also available here for turning of wheel with tread defect.

- 2. CHITPUR This depot maintains both rolling stock Coaching & Goods; maintaining total Thirty Five (35) Mail/Express/Passenger trains, out of which 24 Nos. Primary Maintenance trains, 03 Nos. Secondary Maintenance and 08 Nos. Round Trip Maintenance Trains. Apart from this, it also maintains 01 Automatic Coach Washing Plant (ACWP) and 01 Mechanized Laundry capacity 02.5 Ton per shift. Chitpur Depot also consisting of Freight Maintenance Yard of Close Circuit Rake, Premium Examination and End to End Examination of round the clock and Goods Sick Line for repair of unloadable and heavy repair.
- 3. NAIHATI This depot deals only with Freight Stock such as Intensive examination of Close Circuit Rake, Premium Examination & End to End Examination, Sick Line repair, examination & unloadable and other repair of BDR & other bound trains. Naihati Depot consisting separate ROH Shed for ROH of various types of stock such as BCN, BFKHN, BLL, BLC, BTPN, BOXN, BOXNHL etc. ROH shed equipped with EOT Crane, Wheel turning Lathe, Mounting & Dismounting facilities of bearings have been constructed.

Outturn of newly built wagons from TWL and TEXMACO/SOD examine and necessary fitness given by this depot.

Condemnation and disposal of C&W stock will be done at RE Siding/Naihati after completion of proposed condemnation yard.

- 4. RANAGHAT Mainly dealing with checking/examination, billing of damage & deficiency for Bangladesh bound trains via Gede-Darsona and Petrapole-Benapole International Border Including execution of customs clearance activities. There is also a 'B' Class ART & ARMV in this depot.
- 5. BUDGE BUDGE, MAJHERHAT & EJC DOCK- This depot mainly deals with End to End examination of newly built BOXN wagon and attended road side incident at Budge Budge area.

Majerhat EJC/DOCK depot is under control of Budge Budge Depot, attended Close Circuit rake, Premium examination & End-to-End rake examination & repair work of BLC & BFKHN rakes of CONCOR.

6. KRISHNAPUR – This depot is situated at extreme end Murshidabadh Dist. (W.B.). Only Kolkata Sealdah Lalgola bound Trains are attended this depot as terminal examination. Turn around maintenance of 03 Mail/Express & 04 Passenger trains is done here.

4 b) (ii) Power and duties of Officers and employees

1. Sr.DME(Co)/SDAH

Overall In-Charge of Carriage & Wagon wing and Environment & Housekeeping Management, for carrying out prescribed integrated maintenance of coaches & wagons and Green Cell project. In charge of conducting inspections periodically and monitor proper upkeep of ART/RHA including execution of periodic drills. Ensure implementation of recommendations of High Level Committee Report on Disaster Management & Safety Action plan.

Sr. DME(Co)/SDAH is also a Co-ordinator of Procurement of all M&P Items under Plan Head-41 at Divisional Level (DRM LS).

Co-ordinator of M&P items condemnation when scrap value more than Rs.50,000/-

2. DEnHM/SDAH

In-Charge of Environment & Housekeeping Management Wing. Monitoring and coordination functions for all environment related issues and planning, sanction and execution of environment related works.

3. DME/C&W/SDAH

Ensure integrated maintenance of Sealdah depot coaching stock. Assist Sr.DME (Co) in respect to prescribed integrated maintenance of coaching stock in the Division. Give special emphasis on proper maintenance of safety related parts of coaches. Liaison with DEE(G) for maintenance of coaches. To keep liaison with AOM/Coaching for timely placement of rakes and detachment of coaches for maintenance.

4. AME/NCC/SDAH

Ensure integrated maintenance of Sealdah & KRP depot coaching stock. Implement directives of Sr.DME/SDAH given from time to time and give him feedback. Ensure Mechanized Laundry & Bio-Toilet Laboratory activities. Carry out all other work as and when assigned by Sr.DME (Co).

5. DME/C&W/CP

Ensure integrated maintenance of Chitpur depot coaching & Wagon stock. Implement directives of Sr.DME (Co)/SDAH given from time to time and give him feedback. Carry out all other work as and when assigned by Sr.DME (Co).

6. AME/C&W/SDAH

Ensure integrated maintenance of NH, RHA, BGB& MJT depot Wagon stock. Implement directives of Sr.DME (Co)/SDAH given from time to time and give him feedback. Carry out all other work as and when assigned by Sr.DME (Co).

7. AEnHM/SDAH

Ensure integrated Environment & Housekeeping Management Wing. Monitoring and coordination functions for all environment related issues and planning, sanction and execution of environment related works Ensure integrated maintenance of NH, RHA, BGB& MJT depot Wagon stock. Implement directives of Sr.DME (Co)/SDAH given from time to time and give him feedback. Carry out all other work as and when assigned by Sr.DME (Co).

8. DEPOT IN-CHARGE

All Depot In-Charges ensure integrated maintenance of SDAH, CP, NH, RHA, KRP, & BGB depot coaching and wagon stock. Implement directives of Sr.DME(Co)/SDAH given from time to time and give him feedback. Carry out all other work as and when assigned by Sr.DME(Co).



III. Twin pipe conversion in Wagon:

As per Railway Board instruction, an ambitious project for gradually converted all Single pipe wagons into Twin pipe i.e. addition of Feed pipe & associated component.

During the month of Dec'24, total 16 nos. BCN variant/BOXN wagons & BLC Wagon have been retrofitted with twin pipe which will help in better control of train during freight movement. Cumulative of the year 2024-25 (upto Dec'24) is 146 nos. and cumulative of the previous year 2023-2024 is 751 nos.

V. <u>Door Block & Door Height Reduction as per MR program:</u>



Railmadad Performance:




