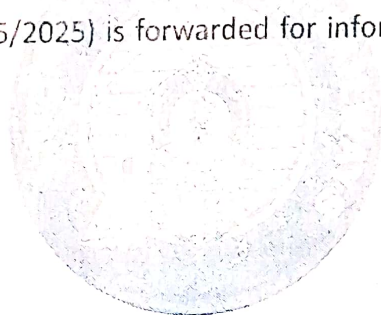

Index No. 1058: A Railway servant covered under NPS is compulsorily retired as a penalty or dismissed or removed from railway service, the lump sum and the annuity out of accumulated pension corpus shall be paid to the railway employee in accordance with the regulations notified by the PFRDA as admissible in case of exit of a subscriber from NPS before superannuation. However, such railway servant may opt to continue to subscribe to the NPS with the same PRAN as a non-government subscriber, in accordance with the regulations notified by the PFRDA.

विषय: राष्ट्रीय पेंशन प्रणाली के अंतर्गत कवर किए गए रेल कर्मचारी के संबंध में, राष्ट्रीय पेंशन प्रणाली के अंतर्गत संचित पेंशन कार्पस पर, अनिवार्य सेवानिवृत्ति या पदच्युति या रेल सेवा से हटाए जाने का प्रभाव-संबंधी।

नई पेंशन योजना (जिसे अब राष्ट्रीय पेंशन प्रणाली (एनपीएस) कहा जाता है) को वित्त मंत्रालय, आर्थिक कार्य विभाग की दिनांक 22.12.2003 की अधिसूचना सं. 5/7/2003-ईसीबी और पीआर के तहत आरंभ किया गया था। इसमें यह उल्लेख किया गया था कि राष्ट्रीय पेंशन प्रणाली 1 जनवरी, 2004 से केंद्रीय सरकार की सेवा में सभी नए प्रवेशकों, जिनमें सशस्त्र बल शामिल नहीं हैं, के लिए अनिवार्य होगी। इसे बोर्ड के दिनांक 31.12.2003 के पत्र सं.एफ(ई)III/2003/पीएन1/24 के तहत सभी रेलों द्वारा अपनाया गया था।

2. उन मामलों में जिनमें राष्ट्रीय पेंशन प्रणाली के अंतर्गत कवर किये गए रेल कर्मचारी को, रेल सेवा से शास्ति स्वरूप अनिवार्य सेवानिवृत्त किया जाता है या पदच्युत या हटा दिया जाता है, तो पेंशन निधि विनियामक और विकास प्राधिकरण (पीएफआरडीए) द्वारा अधिसूचित विनियमों के अनुसरण में, राष्ट्रीय पेंशन प्रणाली से अभिदाता की अधिवर्षिता पूर्व निकासी के मामले में यथास्वीकार्य अभिदाता की संचित पेंशन कार्पस से एकमुश्त और वार्षिकी राशि संदेय होगी।

3. तथापि, पेंशन निधि विनियामक और विकास प्राधिकरण द्वारा अधिसूचित विनियमों के अनुसरण में रेल कर्मचारी, अपने विकल्प पर, एक गैर-सरकारी अभिदाता के रूप में उसी स्थायी सेवानिवृत्ति खाता संख्या के साथ राष्ट्रीय पेंशन प्रणाली में अभिदाय करना जारी रख सकेगा।

4. बहरहाल, उपरोक्त प्रावधान, ऐसे रेल कर्मचारियों को अनुमेय उपदान और अन्य सेवानिवृत्ति परिलाभों के सम्बन्ध में की गई किसी भी कार्यवाही को प्रभावित नहीं करेंगे, और ये लाभ, ऐसे लाभों पर लागू नियमों के अनुसार विनियमित होंगे।

Subject: Effect of compulsory retirement or dismissal or removal from railway service on the accumulated pension corpus under NPS in respect of railway servant covered under the National Pension System -reg.

The New Pension Scheme (now called as National Pension System(NPS)) was introduced vide Ministry of Finance, Department of Economic Affairs' notification No. 5/7/2003-ECB & PR dated 22.12.2003. It was provided that the NPS would be mandatory for all new recruits to the Central Government service from 1st of January, 2004 except Armed Forces. The same was adopted on Railways vide Board's letter No. F(E)III/2003/PN1/24 dated 31.12.2003.

2. In cases where a railway servant covered under NPS is compulsorily retired from service as a penalty or is dismissed or removed from railway service, the lump sum and the annuity out of his accumulated pension corpus shall be paid to him in accordance with the regulations notified by Pension Fund Regulatory and Development Authority (PFRDA) payable to the Subscriber as admissible in the case of exit of a Subscriber from National Pension System before superannuation.

3. However, the railway servant, at his option, may continue to subscribe to the NPS with the same Permanent Retirement Account Number as a non-Government subscriber, in accordance with the regulations notified by the PFRDA.

4. The above provisions shall, however, be without prejudice to any action being taken in respect of gratuity and other retirement benefits admissible to such railway servants and those benefits shall be regulated in accordance with the rules as applicable to such benefits.
