Reference above, it is noticed that a huge nos. of Original Applications (OA), Contempt Petitions and representations have been received all over this railway from the end of retired Railway employees on the above subject matter.

In this regard, the matter has been brought to the notice of the competent authority and the Competent Authority (PCPO) has given approval to allow the notional increment on 1<sup>st</sup> July/1<sup>st</sup> January in favour of all the railway employees who retired/are retiring a day before it became due i.e. 30<sup>th</sup> June/31<sup>st</sup> December and have rendered the requisite qualifying service as on date of their superannuation with satisfactory work and good conduct for the purpose of calculation of pension admissible to them in compliance with para 7 of DOP&T's OM dated 14.10.2024 which has been circulated by Railway Board vide letter as under reference (corresponding PCPO's Sl. No. 137/2024). Enhanced pension has to be paid by taking into account one increment on or after 01.05.2023 (as the case may be). Enhanced pension for the period prior to 30.04.2023 will not be paid.

Necessary action may be taken accordingly, in this regard.
