1. In terms of Railway Board's letter above reference applications are invited in prescribed proforma from willing Retired Non-Gazetted Railway Accounts Staff who have retired from Accounts Department in Pay Level-6 to Level-9, for re-engagement on monthly remuneration basis.

03	Who are eligible to apply	 (a) Retired Railway Non-Gazetted Staff who have retired from Accounts Department in Pay Level-6 to Level-9 from relevant grades on or before the date of publication of notification. (b) Retired Railway Non-Gazetted staff should not have been compulsorily retired or removed or dismissed from service. Retired Railway employees should also be free from D&AR and vigilance cases at the time of retirement (Moreover, he/she should not have any criminal case/ police case pending before any court of law till application date). 			
04	Medical fitness	Must be found medically fit in appropriate category as per Railway Board guidelines			
05	Age limit/period of engagement	Period of re-engagement of an individual retired staff shall be initially period of ONE year or till further order whichever is earlier. However, to on satisfactory performance of a reengaged retired staff, his/her period reengagement can further be extended for a further period of 01 year of attainment of 65 years of age, whichever is earlier. No retired staff should be engaged beyond the validity of the scheme i.e. beyond 15-10-2026. [Re-engaged staff shall be spared immediately on joining of selection candidate(s) from RRB panel or through departmental selection as per recommendation of the competent authority on age cum suitability be even when the minimum period of one year is not completed. However, retired staff are eligible to apply for re-engagement in subsequent engagement cycles.

07	Remuneration	A fixed monthly remuneration shall be admissible during the contract period, arrived at by deducting the Basic Pension from the pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of the contract. Annual increment/percentage increase and DA shall NOT be allowed during the contract period.

Procedure for re-engagement:

	Suitability Competency of the retired staff shall be adjudged by a Committee
Selection/ Suitability and other conditions	nominated by General Manager/Eastern Railway, on the basis of last 05 (five) years
	APARs and viva-voce test, before such re-engagement. While re-engaging such staff,
for re-engagement	medical fitness of the appropriate category shall be obtained from the designated
	authorities as per existing practice.

2. Other Terms & Conditions of contract for Re-engaged Staff:

- (i) Age Limit Maximum age limit of the re-engagement shall be 65 years i.e the re-engagement will stand automatically terminated on attaining the age of 65 years. (Eligibility will be considered from the date of publication of notification)
- (ii) Terms of reference of the work to be assigned i.e. roles and responsibilities: Work related to any HQ offices of Accounts Department/Eastern Railway (as per requirement)
- (iii) The re-engagement of the staff is purely on temporary basis and shall not be considered as a case of reemployment. Period of such re-engagement will not be counted as service for any purpose as admissible to regular serving staff.
- (iv) The re-engaged staff will not be covered under any statutory enactment admissible to serving employees.
- (v) The re-engaged staff shall not be given any financial and disciplinary powers and shall not be authorized to issue safety or any other certificate. Re-engaged staff may recommend their suggestions on financial and other matters to regular officials.
- (vi) The re-engaged staff shall not divulge any information gathered by him/her during the period of assignment related to the organization to anyone who is not authorized to know / have the same. For this purpose, the staff shall sign an agreement of confidentiality with the Govt. of India containing a clause on Ethics and Integrity.
- (vii) The integrity aspect will be checked while permitting such re-engagement.

- 3. Leave: Paid Leave of absence may be allowed at the rate of 1.5 days for each completed month of service. Accumulation of leave beyond a calendar year will not be allowed nor carried forward in case the engagement is extended. Also, no payment in lieu of unutilized leaves will be paid at the time of discharge /expiry of the contract. [Ref: Point no. ix.(d) of Railway Boards Letter No. E(NG)II/2024/RC-4/9 dated 15.10.2024 (RBE No.96/2024)]
- 4. Re-engaged staff shall not be entitled for increment, Dearness allowance and HRA during the term of contract. However, an appropriate and fixed amount as Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement. The amount so fixed shall remain unchanged during the terms of appointment. Retired employees may be allowed TA/DA on official tour, if any, as per their entitlement at the time of retirement. - 5. The re-engaged staff may be posted at any accounting unit in Accounts Department/HQ/Eastern Railway area.
- 6. The shortlisted retired staff should be in readiness to appear before selection committee for scrutiny which is proposed to be held immediately after closing date of submission of application.
- 7. Retired employees being re-engaged will not be covered under the Safety Related Retirement Scheme/Liberalized Active Retirement Scheme for Guaranteed Employment for Safety Staff (LARSGESS). [Ref: Point no. v. of Railway Boards Letter No. E(NG)II/2024/RC-4/9 dated 15.10.2024 (RBE No.96/2024)]
- 8. Submission of Applications: Applications should be submitted in prescribed proforma as per Annexure-I & II and should be sent by Hand to Dy.
