On 05.02.2024, a passenger namely Md. Ilyas, S/O- Gul Mohamad, R/O- Sahin Bagh, Jamia Nagar, Delhi was travelling in Train No. 22347 from HWH to PNBE. In course of journey when the said train stopped at ASN Railway station, he deboarded from the train for collecting food items. In the meantime the train started and the door was automatic closed. Unfortunately, he couldn't board in the train and his luggage has been left behind in Coach No.C-7, Berth No. 36 of the said train. On getting information, officer and staff of RPF Post JSME attended the coach and recovered the luggage. Accordingly, recovered luggage was brought to RPF Post JSME. After sometime, one person namely Md. Seized the all liquor in presence of available witnesses, no independent witness came forward to witness the seizure. Later the seized liquor handed over to RPF/Post/MDP for further disposal. After observing all legal formalities, seized liquor bottles are forwarded to Excise Department/ Deoghar (JH) for further action.

06.02.24 **Operation "DIGNITY"**

Imperial blue Small 375 MI each value 330/- from possession of Sourav Yadav (M-18 yrs.) S/O Lt. Jageswar Yadav R/O Vill-Palbagan Mihijam, PS. Mihijam, Dist. Jamtara, Jharkhand and with seized 39 nos. Imperial blue Small 375 MI each value 330/- & 01 no. officer Choice country 750 ML value 570/- & 02 Nos. Old Mock small 375 ML each value 290/- & 04 Nos. Old Monk big 750 MI each value 560/from possession of Kartick Yadav, (M-19 Yrs.) S/O Sapindar Yadav R/O Vill-Palbagan Mihijam, PS. Mihijam, Dist. Jamtara, Jharkhand Total seized 39.750 liters and value Rs. 34,210/- in proper seizure list in presence of available witnesses at RPF/Post/Jamtara. They were taken into custody for committing offence of carrying liquors in train illegally. The arrested persons were kept under custody at RPF/Post/JMT. On date 13.02.2024 arrested persons with seized articles and relevant papers are being handed over to Excise department, Jamtara for its further legal disposal.

After that the rescued boy was handed over toChildline/Asansol for further legal action.

After that the seized liquors were handed over to Excise department, Jamtara under proper documentation for further legal disposal.

While the train started moving to departure Madhupur Station at 02:19 hrs. but in the twinkling of an eye one person tried to board the S1 while the train was running motion and they were standing at the adjoining gate. But the person slipped and lost his balance. Consequently he was hanging from the gate and his body entangled in the gap of train and platform. Seeing this critical situation CT/A.K.Sah immediately reached the said gate and hold his both hand. He tried every trick in the book to pull out him but the said person was unable to board the train. Seeing this situation ASI/K. Halder immediately applied ACP to stop the train from S-1 Coach. After that he was pulled out from that gap and made him sit on a berth. They noticed his pant went torn and he got injured in his both legs. On being asked he disclosed his name Virendra Kumar Gupta and he was travelling from BaktiarPur to Hawrah in S 2 berth No 16 having PNR No 6231544570. He was asked what was the reason for his deboarding? He answered that he deboarded to buy a water bottle from the platform shop. In the meantime, the said train was started. That's why he tried to board the said running train. In this regards a written application was taken from him wherein he mentioned the whole matter. Two eye witness also put their signature in it and gave their PNR &Moible number.

Victim demanded medical treatment before us. After that on duty TTE informed concerning department. Accordingly, doctor came to Asansol and medical treatment was provided him. On being enquired from T/guard it came to know that train suffered detention from 02/20 hrs to 02/22hrs.

ASI/K.Halder/a/w 05 staffs of RPF Post Durgapur were detailed for T/E duty in T/NO- 12352DN.EX- JSME to DGR to keep special watch on boarding &deboarding of passengers. While the train started moving to departure Madhupur Station at 02:19 hrs. but in the twinkling of an eye one person tried to board the S1 while the train was running motion and they were standing at the adjoining gate. But the person slipped and lost his balance. Consequently he was hanging from the gate and his body entangled in the gap of train and platform. Seeing this critical situation CT/A.K.Sah immediately reached the said gate and hold his both hand. He tried every trick in the book to pull out him but the said person was unable to board the train. Seeing this situation ASI/K. Halder immediately applied ACP to stop the train from S-1 Coach. After that he was pulled out from that gap and made him sit on a berth. They noticed his pant went torn and he got injured in his both legs. On being asked he disclosed his name Virendra Kumar Gupta and he was travelling from BaktiarPur to Hawrah in S 2 berth No 16 having PNR No. - 6231544570. He was asked what was the reason for his deboarding? He answered that he deboarded to buy a water bottle from the platform shop. In the meantime, the said train was started. That's why he tried to board the said running train. In this regards a written application was taken from him wherein he mentioned the whole matter. Two eye witness also put their signature in it and gave their PNR & Moible number. Victim demanded medical treatment before us. After that on duty TTE informed concerning department. Accordingly, doctor came to Asansol and medical treatment was provided him. On being enquired from T/guard it came to know that train suffered detention from 02/20 hrs to 02/22hrs.

14.03.24 **OPERATION SATARK:-**

On 14.03.24 Train escorting party of train No. 13186 down Ganga Sagar handed over one Mohit Kumar with a trolley bag to RPF Post Asansol West. It is alleged that Mohit was found in B-6 of train No. 13186 without ticket, suspected to be a TOPB criminal. Interrogation at RPF Post west reveals name and address of that person is Mohit Kumar (M/21 yrs.) S/O-Avdesh Kumar of vill- Nimarang, P.O+P.O-Jamui, Bihar. He boarded in 13186 down from Jhajha and was to take the trolley bag to Howrah. As checked found the trolley containing **Rs. 50 lacs.** Mohit could not disclose much about the money. He told that some Jimmy of Jamui had given him the bag and at Howrah someone was to collect it from him. As asked about the owner Mohit could only mention about some Gourav, building contractor of Patna whom he never meet. For further disposal Income Tax department from Asansol branch is called and with a complaint to Dy.Director Income Tax Asansol the detained person Mohit with the cash Rs. 50 lacs is handed over to Dy. Director

Income Tax Asansol. The cash is seized from the possession of Mohit by IT
department vide section 132 IT Act for further necessary action U/S 143&147 IT
Act. Mohit is released by IT Department with a summon to appear at the office of
IT at Asansol on 20.3.24 for further enquiry.

20.03.24 **Operation AMANAT:-**

On 08.03.2024, one passenger namely AritraSenGupta, who was travelling by Train no. 22307 Up (HWH Bikner Express) from HWH to DDU vide PNR No.6903071445 had left behind the purse of his wife containing Samsung mobile (S-10), passport of his child, PAN Card, and 07 ATM card in the train. Accordingly, the said purse was recovered by the Train Escort party of the train and deposited to RPF West Post Asansol. On 20.03.2024, the passenger attended RPF Post Asansol (West) and demanded the purse worth Rs. 75,000/-. After verification the recovered purse containing the above articles was handed over to him.

He was shouting "please save me", his right hand got almost separated near elbow and was bleeding badly. Matter was informed to on duty SM/KMME, he provided stretcher and issued a memo in this regard but denied to provide any staff. On duty RPF staff and GRP staff took him to a nearby private hospital at KMME where First Aid was provided and refer to Sadar Hospital Asansol. After that ASI/R.A Singh with staff took him to Asansol by departmental vehicle and admitted at Sadar Hospital/Asansol, Male Surgical Ward Bed No. 237 for better treatment. The person was disclosed his identity as Palash Das, Male 39 yrs, S/O- Samir Das, C/O-Sabita Das, Mandal Para, PS-Das Nagar, Dist-Howrah (WB). One General ticketNo. 32573687, dtd 01.04.2024 Ex- KMME to HWH found from his possession.

02.04.24 **OPPERATION NANHE FARISTE**

On 02.04.2024officer and staff of RPF Post Asansol (W) noticed that one minor boy namely Nitesh Kumar, M/9 yrs., S/O Punyadeo Paswan of ward No.17, Vill-Khurahiya, East Chamaran, Biharwho was moving aimlessly alone on PF No. 2 of Asansol Railway Station and on being asked he replied that he was fled away from his native place on dtd. 01.04.2024 due to reprimand by his mother. The rescued boy was brought to the Post where after documentation handed over to Railway Child line Asansol for further legal action and also informed to his father over mobile phone.

On 02.04.24, a train no. 12303 arrived on PF no. 03 of Durgapur Railway Station at about 09:50 hrs. After its scheduled stoppage the train started departing at

09:59 hrs. When the train had picked up the momentum, one lady passenger ran towards the train and tried to board into the moving train but unfortunately lost her balance due to her heavy weight and was about to fall into the gap between the running train and the platform. But, on duty platform staff LC/S.L.Sutar of RPF/Post/Durgapur acted promptedly and pulled up the subject lady and saved her life from getting gripped into an unfortunate accident. In this quick action LC/S. L. Sutar lost her own balance resulting which she fell on the platform and got scant injured. In this regard, the identity details of the subject lady could not be obtained

During journey, when the said train arrived at Jhajha Railway station, he got dawn from the said train for some reason. At the mean the train departed from the station and his one bag containing wearing cloths, documents & Lenovo Laptop left behind in the said train. Immediately, he informed this matter to on duty RPF staff. On getting information from on duty seal checking staff of JAJ, SI/P.K.Rao of RPF Post JSME came in prompt action and attended the said train and succeeded in recover the said bag. On 04.04.2024, Roshan Kumar appeared at RPF Post JSME and the recovered bag containing wearing cloths, documents & Lenovo Laptop (Valued: Rs. 100000/-) was handed over to him after proper documentation and acknowledgement.

13.04.24 **OPERATION JEEVAN RAKSHA**

On 13.04.2024, at about-15.00 hrs. Train No.11448 up arrived at PF No-3 of Durgapur Station and left at 15.15 hrs. in the meantime one lady person trying to board in the running train and she was fell down and her body went in the gap of platform and train, where due to prompt action of on duty RPF staff namely HC/6349 Samir Bandyopadhyay pulled out the lady and also lost his balance and fell down on the platform and sustained minor injury. On being asked the lady was disclosed her identity as Sushila Das, F-67 yrs., W/O- Lt. Arjun Prasad,R/O-Ouarter No.75,Kurpaniya More, Sunday Bazar, Bokaro, Barmo, PS-Gandhinagar, Distt-Bokaro, State-Jharkhand, 829127, due to brave efforts by on duty RPF staff she managed to save her life. Due to such incident she got slight injury on her body.

14.04.24 **Operation "AMANAT"**

On 14.04.2024, a passenger namely Niraj Kumar Singh, S/O- Lt. Maheswar Prasad Singh, R/O- Barh, Patna, Bihar was waiting for train at Jasidih Railway station for travel from Jasidih to Bokaro. While waiting he slept near main gate of Jasidih Railway station and his mobile phones fell out of the pocket in sleep. HC/Bijay Kumar of RPF Post JSME was performing Baggage Scanner duty at main gate of Jasidih Railway station. He recovered the said mobile phones and convey it among the passengers but no one came forward to claim it. After that said mobiles were

brought to RPF/POST/JSME. Accordingly, Niraj Kumar appeared at RPF Post JSME for enquired about his phones and said recovered mobiles i.e. One Oppo company android mobile & One Moto 5G mobile (**Total Valued: Rs. 36,000/-)** was handed over to him after proper documentation and acknowledgement.

The injured person's son namely Raja Seikh M-21 S/O Nasuriddinhn Sekh of Dohri, PS- Margomunda, Madhupur, Dist- Deoghar Jharkhand submitted a written complainto OC/GRPS against such Act, on the basis of such written complain GRPS/MDP registered a Case Vide No. 03/2024 dtd. 15.04.2024 U/S-341/323/307/379/506/34 IPC against the above persons at GRPS/Madhupur.

16.04.24 **Operation "MATRISHAKTI"**

On16.04.2024 at about 04.15 hrs. getting information from on duty Dy. SS/ASN regarding a passenger namely Sita Choudhury (F-25 years) W/O Akhilesh, Mob No. 6372070846, delivered a new born baby on PF No.06 near Pay & use Toilet at Asansol Rly Station, They have journey by train no.18449 Puri Patna Exp Vide Ticket No. 95484664. Accordingly, officers and staff of West Post ASNand GRPS ASN attended the spot and she was shifted to SD Hospital Asansol by Railway ambulance with assistance by LHC Jhuma Ray of RPF West Post Asansol. She was admitted to female Ward Bed No.29 under the treatment of Dr. Bansi Vishal.SM/ASN issued a memo in this regard.

21.04.24 **Operation"JEEVAN RAKSHA"**

On 21.04.2024, T/No. 13121 UP arrived at PF No. 03 of Durgapur Stationat 22:17 hrs. and left at 22:21 hrs. but suddenly stopped due to ACP in Coach No. 222545. (M-1). Accordingly officers and staff of RPF Post Durgapur attended the train and it came to know that 01 person while boarding in the sleeper Coach having PNR No. 6434345394 has fallen down on platform and entered into the gap between edges of the platform and the train, that's why one passenger having PNR No.

6532490252 of (M-1) Coach applied ACP for save his life. Immediately, on duty staff of RPF Post Durgapur, HC/ T.Sinha and LC/Asima Das pulled the fallen passenger and save his life. Identity of the passenger as Sanjoy Kumar Pandey, M/39Yrs.. S/O, Jogeshwar Kr. Pandey, Vill- Parshagar, Chapra, PS- Ekma, Dist-Chapra, Bihar. Accordingly matter has been enquired with the CCTV footages of DGR Railway Station which corroborated the above facts.In this regard a memo has been issued by on duty T/Guard and mentioned that rectified by TM and due this incident the train suffered detention from 22:21 hrs. to 22:28 hrs. i.e. 07 minutes. As the matter was genuine, no case has been registered at RPF Post Durgapur.

On being asked he disclosed his identity as Rajeev Singh, M/54 yrs. S/OLate Avadhesh Singh, R/O. Vill—Solahpur, P.O-Bara, P.S.-Chandradip, Dist.-Jamui, Bihar having UTS No. 428MDRUIA4. EX. Durgapur to Jasidh Railway Station. On being asked he stated that he is well and no any need of medical assistance.

On 01.05.2024 during round, ASI Md. Altafuddin noticed that one minor child (girl) aged about 04 years moving suspicious at ASN PF No. 5 near RMS office of ASN Rly Station. On ground of suspicion the girl was detained and on being asked the minor girl was disclosed her identity as Nima, D/O Basant of Kotshila, Jhalda, Dist-Purulia, West Bengal and also informed that she came to ASN with her sister but her sister left her at ASN PF 5 and flew away from ASN. Further, on interrogation with the children mentioned as (I) Azruddin Ansari, M(12 yrs), S/O- Sarif Ansari, R/O- Kheribani, Bansjori, Godda, Jharkhand (II) Mujahid Ansari, M(11 yrs), S/O-Sattar Ansari, R/O-Kheribani, Bansjori, Godda, Jharkhand (III) Ikram Ansari, M(9 yrs), S/O-Mannan Ansari, R/O- Kheribani, Bansjori, Godda, Jharkhand(IV) Arbaz Ansari, M(13 yrs), S/O- Lalbasu Ansari, R/O- Kheribani, Bansjori, Godda, Jharkhand (V) Minhaj Ansari, M(12 yrs), S/O-Mujjafar Ansari, R/O- Kheribani, Bansjori, Godda, Jharkhand (VI) Asfaq Ahmad, M(10yrs), S/O-Majibul Ansari, R/O- Gram Raksha Kitta, PO-Mahagama, Godda, Jharkhand (VII) Hasib Ansari, M(12 yrs), S/O-Firoz Ansari, R/O- Kheribani, Bansjori, Godda, Jharkhand (VIII) Sohail Ansari, M(11 yrs), S/O- Kalam Ansari, R/O- Raksha Kitta, PO-Mahagama, Godda, Jharkhand (IX) Fahran Ansari, M(13 yrs), S/O- Ramjan Ansari, R/O- Kheribani, Bansjori, Godda, Jharkhand (X) Ajhar Ansari, M(12 yrs), S/O- Lt. Accordingly, they provided contact number of their parents and on asking to their parents they confessed that they sent their child in their own consent. Thereafter, on 05.08.2024 all the 10 nos. children a/w 02 adult persons were handed over to CWC/Godda for further counseling as per JJ Act 2015.

Upon investigation, CCTV footage at Asansol was reviewed, revealing that the complainant's brother had accidentally dropped the phone near the barricade. The recovered phone(Apple 13 **valued at Rs. 80,000/-)** was handed over to him after proper verification.

S-4, berth no. 10 of a bonafide passenger namely Rahul Jain, PNR No. 6739798719, Mob: 8512995557 travelling from HWH to ASN station. On receipt of information, train escorting party attended said coach and recovered the sameand deposited the same at PS-Cell/ASN. The complainant was also informed to come at PS-Cell/ASN to receive his left behind Mobile Phone. On 07.08.2024 the said passenger arrived at PS-Cell/ASN and after proper verification, the recovered Mobile phone 'Samsung Galaxy Z Fold', valued Rs.1,70,000/- approx has been handed over to him after proper verification.

09.08.24 **Operation "Yatri Suraksha"**

On 09.08.2024, officer and staff of RPF Post JSME conducted raid in civil cloths against TOPB criminals at Jasidih Railway Station premises as well as in trains in between MDP-JAJ section. During their special watch, when the train No. 12333 arrived at about 12:10 hrs. at PF No. 02 of JSME station, noticed that a person in S-2 coach of siad train in suspicious manner. Accordingly, approached towards him and by seeing this he tried to run away. Accordingly, detain the suspected person near FOB of PF No. 02 by hot chasing. Accordingly, the culprit was brought to RPF Post JSME for further interrogation. On being asked, he disclosed his identity as Roshan Kumar, M (22 yrs), S/O- Bijay Mondal, R/O- Dasrathi, PS- Dharhara, Dist- Munger, Bihar and while doing his personal search, found03 nos. Mobile phones i.e. i) Dark Blue coloured Samsung Mobile, ii) White cream coloured Samsung Mobile phone, iii) Dark Green coloured POCO mobile phone (Total Value- 95000/-) found from the possession of the said culprit. On asking about mobile phone, he could not give any satisfactory answer and he also could not able to unlock the said mobile phones by entering password. Accordingly he confessed that he had stolen the said mobile phones from the railway passenger.

Thereafter, arrested person with recovered stolen mobile phones were

handed over to GRPS/Jasidih for further legal action. In this regard a case has been registered in GRPS/Jasidih Vide Case No.74/2024 dtd 09.08.2024 U/S 317 (5) BNS.

"Operation Narcos":- On dated 16.11.2024, a letter has been received by this post from Parcel office/MDP/E.Rly with mentioning L.No. Nil Dt. 12.11.2024 of CPS/Ranchi dt. 15.11.2024 regarding search and verify the goods declared & booked vide 1. PRR No.- 4002051696 Ex. BSB to MDP, 10 Nos P/Bdl, containing Manihari Goods total weight 348.00Kg with invoice no. B1123787, party name-Shivam-Morena at BSB & 2. PRR No.- 4002048920 Ex BSB to MDP, 20 Nos P/Bdl, containing Manihari Goods total weight 642 Kg with invoice no. B1123617, party name- Shivam - Morena At BSB. both Ex BSB to MDP . Received at MDP station on dt. 14.11.2024. On dt. 16.11.2024 RPF/MDP ASI/Narendra Kumar reached at Parcel Office MDP where found the item is declared/mentioned in PRR as Manihari Goods. Then above items jointly checked in presence of Chief Parcel Supervisor/MDP & receiver/representatives of booked parcel namely Pranesh Gupta, Male- 38 yrs. about, S/o- Lt. Abhik Prasad Gupta, R/o- 52 Bigha, P.S.-Madhupur, Dist- Deoghar, JH. & SM/MDP, CTI/MDP. Found that the booked parcel is not Manihari Goods, it is Pan Masala & Jarda & prepared a joint note in this regard. It is found that this is false declaration of said booked items. In this regard the above items have been seized in presence of available witnesses from the possession of custodian(CPS/MDP) in presence of representative of sender. During seizing weighting of the items has been done & found total 940 kg only, counted total items & MRP value that is mentioned in seizure list prepared. Total value is **873600/-** rupees.

As per requisition received a/w PRRs from receiver/representatives of booked parcel namely Pranesh Gupta, Male- 38 yrs. about, S/o- Lt. Abhik Prasad Gupta, R/o- 52 Bigha, P.S.- Madhupur, Dist- Deoghar, JH forwarded by CPS/MDP in which mentioned that the above items booked at BSB as Manihari Goods, declared wrong mistakenly. While the booked item is Pan Masala & Jarda & requested to hand over the said items.

As per joint note prepared in this regard, a case no.- 2157/2024, u/s- 163 RA, Dt.- 16.11.2023 is registered against absconded Shivam-Morena BSB & enquiry is endorsed to SI/Shyam Sundar Kumar of RPF Post MDP.

"Operation Satark":-On 18.11.2024, an intensify drive/preventive check conducted by the team of D&I wing/HQ with assistance of D&I Wing/ASN against illegal transporting of contraband items and liquid cash by mail/express trains as well as station premises in view of Assembly Election of Jharkhand State which may be used in election purpose. During such drive, on creditable source & information of HC/Abhijit Bag of D&I Wing/HQ/ER, checked front side general coach No. ER 112421 OF T/No-13185 UP (Gangasagar Exp.) after departure from Asansol Railway Station from 02.30 hrs. During checking, the team noticed that 05 nos. Big cartoons wrapped with plastic chat & 01 big plastic bag kept under the seat in suspicious condition. Firstly, several efforts have been made amongst the passengers to trace out the actual owner of these cartoons/bag but in vain. However, the passengers seated on the berth where the items kept, were interrogated regarding loading station of the articles but nobody replied about it. On the suspicious ground we checked the cartoons & bag and found that it was

full with Foreign made liquors & Bears. On arrival of the said train at Jamtara Railway station at about 03.20 hrs. of 18.11.2024, the said cartoons & bag brought down from the said compartment on PF No-01 (JSME end). Again, waited for the its actual owner but no one turned up to claim it. Hence, found no alternative way, the cartoons and bags were opened in presence of available witnesses and found 03 small cartoons in each big cartoons i.e. total 15 cartoons. Out of which, 48 nos. Officer Choice Elite Whiskey tetra pack/180 ml each (Price Rs. 130/- each tetra pack) in 14 cartoons and 38 nos. Officer Choice Elite Whiskey tetra pack/180 ml (Price Rs. 130/- each tetra pack) in 01 cartoon, i.e. Total 710 tetra pack valued Rs. 92,300/- and 07 packets contained 06 nos. of Haywards 5000 Premium Strong Bear in each packet(500 ml each, printed price Rs. 110/-/each) kept in 01 nos. Big size plastic bag i.e. total 42 nos. Cane bear valued Rs. 4620/-. Grand Total -148.8 ltrs and valued Rs. 96,920/-. Thereafter, seized all the above articles on the spot from 03.50 hrs. To 04.30 hrs. under proper seizure list in presence of available witness as unclaimed & handed over to RPF/Post/Jamtara for taking legal action in purview of law.

All legal formalities were done and information was given to Excise Department of Jamtara. Finally following due documentation the seized liquors were handed over to the Excise Department of Jamtara for its further legal disposal.

K. Sao ASC /Rampurhat. It is found out during enquiry that team was active to work out an input regarding carrying of cash from Rampurhat to Dumka area. The team attended Rampurhat station and kept close watch on two suspected persons at Platform number -2 at about 15.10 hrs and later both the persons were seen boarding in train No.13015 Kaviguru express (HWH-Jamalpur) express in D-2 coach. The train left Rampurhat at 15.31hrs. In course of checking in D-2 coach one passenger was found travelling in suspicious condition in 27 & 28 and his other companion was not found at his seat. The individual appeared to be in a nervous and suspicious state, was immediately placed under surveillance by the team. Upon further monitoring, he attempted to avoid detection and tried to leave but the team chased and proceed with a search. He was detained and n interrogation he disclosed his identity as mentioned above.
