

1. In order to fill up ex-cadre post of Sainik & Watcher in pay band Level-1 of Pay Matrix, G.P. Rs. 1800/- in vigilance organization of Eastern Railway, it has been decided to hold viva-voce test for formation of a panel.
2. VACANCIES = 09 (Existing Vacancy – 06, Anticipated Vacancy – 03)
3. **ELIGIBILITY:-**
 - (i) In order to induction of Sainik & Watcher in L-1 GP Rs.1800/- under GM/VIG/ER, applications are invited from the willing candidates who are working in same level and Grade pay.
 - (ii) The posts are ex-cadre and the administration has reserved the right to repatriate the staff to their parent departments at any time without assigning any reasons therefore.
 - (iii) The Staff who has already completed his/her tenure in Vigilance Organization of Zonal Railways/Production Units/Railway Board earlier as Watcher/Sainik is not eligible to apply. However, if he/she has completed sufficient cooling off period of minimum 02 years as on 07.05.2025, thereafter he/she is eligible to apply.

- (iv) The staff should have sound integrity, should not be figuring in any current Vigilance/SPE/DAR case and should not have been imposed any Major/Minor penalty in a Vigilance/CBI case during the entire service period.
- (v) The Candidate should have working experience in photocopying / Scanning etc.
- (vi) Candidates should not have exceeded 55 years of age as on May 7, 2025.
4. **Once application of candidate forwarded through proper channel, his/her candidature may not be withdrawn for any reason, if he/she selected for the post of Watcher/Sainik.**
5. **FORWARDING OF APPLICATION:**
Applications of the eligible volunteers should be duly filled up in the enclosed proforma and submitted through proper channel duly forwarded by their Controlling Officer, to Eastern Railway Vigilance Department. Application of eligible candidates of other Railways should be duly filled up in the enclosed proforma and submitted through proper channel duly forwarded by their Controlling Officer, to the respective Zonal Railway/Unit Vigilance Department. The concerned Zonal Railway/Unit Vigilance Department shall forward the applications of only eligible candidates received by the due date, to Eastern Railway Vigilance Department along with current Vigilance/SPE/DAR clearance and the past vigilance history of each applicant.
6. The Last Date of receipt of application in the prescribed proforma in this office is **06.06.2025.**
7. It may be ensured that only applications of the eligible staff having proven integrity are forwarded. The applications received through Vigilance Department of other Zonal Railway/Unit will only be entertained for the applicants of other Railway/Unit.
8. Notification may please be given wide publicity and this should also be displayed prominently on notice boards for information of the staff.
