Sub:- Selection for 02 post of Chief Vigilance
Inspector (Mechanical) in Level 7 of Pay
Matrix under GM/Vigilance/Eastern
Railway, Kolkata.

2.0 In order to fill up ex-cadre post of CVI/Mechanical in pay band Level-7 of Pay Matrix, G.P. Rs. 4600/- in vigilance organization of Eastern Railway, it has been decided to hold a selection for formation of a panel.

3.0 ELIGIBILITY:-

- (i) Staff working as Technical Supervisor of Mechanical Department in Level-7 of Pay Matrix or one scale below, i.e. in Level-6 of Pay Matrix, on regular basis.
- (ii) The Staff who has already completed his/her tenure in Vigilance Organization of Zonal Railways/Production Units/Railway Board earlier as Vigilance Inspector/ Chief Vigilance Inspector/Investigating Inspector (Vigilance) is not eligible to apply. However, if he/she has completed sufficient cooling off period of minimum 02 years as on 07.05.2025, thereafter he/she is eligible to apply.

- (iii) Staff working in Level 8 & Level 9 pay matrix are also eligible to apply for the post. However, the staff selected for the post of CVI will be transferred to Vigilance branch along with the post of Level 8/9.
- (iv) The staff should have sound integrity, should not be figuring in any current Vigilance/SPE/DAR case and should not have been imposed any Major/Minor penalty in a Vigilance/CBI case during the entire service period.
- (v) Candidates should have 05 years experience in working in Mechanical department as on 07.05.2025
- (vi) Candidates should necessarily be less than 55 years as on 07.05.2025
- (vii) Computer efficiency is also a desirable qualification.

4. The post of CVI/Mechanical is an ex-cadre post with normal tenure of three years from the date of induction and in addition to that the tenure may be extended up to 05 years in individual cases of special merit. The administration reserves the right to repatriate the staff to their parent department at any time without assigning any reason.

5. SELECTION PROCEDURE:-

The selection will comprise of a written test followed by a Vigilance Aptitude and Computer Knowledge Test. The candidates who obtain at least 60% marks in the written test will be called for Vigilance Aptitude and Computer Knowledge Test.

The distribution of marks for the selection is as bellows:

6. FORWARDING OF APPLICATION:

Applications of the eligible volunteers duly filled up in the enclosed proforma and submitted through proper channel duly forwarded by their Controlling Officer, to Eastern Railway Vigilance Department. Application of eligible candidates of other Railways should be duly filled up in the enclosed proforma and submitted through proper channel duly forwarded by their Controlling Officer, to the respective Zonal Railway/Unit Vigilance Department. The concerned Zonal Railway/Unit Vigilance Department shall forward the applications of only eligible candidates received by the due date, to Eastern Railway Vigilance Department along with current Vigilance/SPE/DAR clearance and the past vigilance history of each applicant.

7. The Last Date of receipt of application in the prescribed proforma in this office is 06.06.2025.

8. One application of candidate forwarded through proper channel, his/her candidature may not be withdrawn for any reason, if he/she selected for the post of CVI.
9. It may be ensured that only applications of the eligible staff having proven integrity are forwarded. The applications received through Zonal Railway/Unit Vigilance Department will only be entertained for the applicants of other Railway/Unit.
10. Notification may please be given wide publicity and this should also be displayed prominently on notice boards for information of the staff.
