

EOI (Expression of Interest) towards setup of "Hemodialysis Unit" at Eastern Railway Workshop Hospital, Liluah on PPP arrangement.

"Chief Medical Superintendent / Eastern Railway Workshop Hospital, Liluah is inviting application from reputed firms to setup a "Hemodialysis Unit" at Eastern Railway Workshop Hospital, Liluah on PPP arrangement.

Terms and condition:

1. Eligibility criteria of the firm: The firm should have a minimum of 5 years of experience in running hemodialysis centre with a operational hemodialysis unit under their management.

2. Railway's responsibility:

Railway authority will provide necessary space (as per INA norms) in the earmarked area (predefined) with connection for sufficient uninterrupted water supply and also electrical connection with sufficient electrical load as required for running of a Hemodialysis Unit.

3. The private firm's (service provider) responsibility :

i. The firm responsible for modify the area as per their requirement and establish the Hemo-dialysis center with minimum four (04) dialysis machines with a provision of another machine for dedicated sero-positive cases if requited later on within the stipulated period as per agreement.

ii. Hemodialysis machine and consumables as well man power and maintenance will be provided by the firm for which brand new hemodialysis machine with breakdown maintenance have to be provided throughout the period of contract. Substitute dialysis services should be arranged / provided by the firm during breakdown or other unforeseen situations with in approachable areas without any extra cost.

iii. All consumables such as intra procedural medicines, dialyzer, filter, tubing and other accessories will be provided by the firm without any extra cost.

iv. All necessary permissions from statutory body should be arranged by the firm.

v. Railway Hospital will not be responsible for any untoward incident due to medical attention given by the centre.

vi. Cleaning and housekeeping of the entire area under their possession / designated area has to be manage by the firm.

vii. Biomedical waste during contract should be disposed by the firm as per existing norms set by pollution control Board of state government.

viii. One full time nephrologists with recognized degree (during dialysis period) should be in the pay roll of the firm for back up (during any unforced incidence) if necessary by the dialysis patient. He / she will also visit to Railway Hemodialysis unit once a week for inspection and also provide OPD consultation (at a suitable consultancy room will be provided) to the dialysis patient /CKD patients of Railway Hospital Liluah.

ix. The dialysis will be performed under guidance of qualified dialysis technicians / paramedical/ nursing staff/ attendant which will be provided by the firm.

x. In case of emergency arising due to any reason, the firm will take all necessary measure for suitable management of the case including shifting of the patient to proper referral centre. This will be done in consultation/ information to the hospital administration.

xi. The bidder should vacate Railway space within one week of contract termination.

4. Deciding factors for acceptance of firms:

i. Hemodialysis charges of the Railway employees will be free.

ii. The firm will be allowed to treat private patients at their rate and term and condition in vacant slots after providing dialysis to Railway beneficiaries on priority. Thus they can make profit out of that, which will their earning.

iii. If firm conduct hemodialysis of non Railway patient on their own hospital rates, the firm have to share their profit with Railway through a system as recommended by the Railway authority.

iv. Proper account of charges paid by non Railway patients to the firm has to be kept. Separate registers for all types of expenditure should be maintained. All records should be readily available at dialysis centre and be produced for inspection on demand of authorized Railway personnel.

v. The percentage of profit sharing of Haemo-Dialysis toward the Non Railway Beneficiaries and credential of the firm will be deciding factor for acceptance of firms, if there are more numbers who have fulfilling all the credential set down by the Railway authority. (Credential of firm will be fixed by Railway medical authority). Bidders are encouraged for pre-bid site inspection and meeting with CMS / ACMS (Admin) / Liluah for which representative of the firm may visit Hospital on any working day at working hours with prior appointment through e-mail.

All interested firm may apply with details of their term and condition if any to Chief Medical Superintendent, Eastern Railway Hospital, either by hand or post or e-mail.


