B) IMPORTANT POINTS :-

No staff will have or can claim a legal right to continue the post in the Vigilance Organisation either indefinitely or for a specific period.

- A Written examination followed by Vigilance and D&AR Aptitude Test and Computer Knowledge Test may be conducted as part of selection procedure. The candidates who obtain at least 60% marks in the written test will be called for Vigilance and D&AR Aptitude Test and Computer Knowledge Test.
