As the Railways are aware, the training period spont by a railway servant, whether on remuneration of stipend or otherwise, is to be treated as duty, provided it is followed by confirmation, for the purposes of increments.

- One of the Zonal Railways has sought to know whether the period spent at home during nation wide lockdown due to COVID-19 pandemic be reckuned as duty also for the purpose of increments.
- 3. It is hereby clarified that the Board had already issued instructions vide RBE No. 109/2020 on releasing of held up payments of stipends to the trainee railway servants for the period they had stayed at home during the lockdown due to COVID-19, subject to a condition that this period must not exceed six months.
- 4. In view of this, the matter has once again been examined and it has further been decided that as a one-time measure the stay-al-home period (up to a maximum of six months only) of trainee railway servants due to nationwide lockdown due to COVID-19 may be treated as duty for the purposes of increments.

Pursuant to a demand raised by the Staff Side (AIRF) vide PNM Item No.31/2018, It is hereby clarified that the term used in RBE 23/1998 for the erstwhile Group 'D' staff (erstwhile Khalesi & Khalesi & Khalesi & Helpers) eligible to appear in the selection for promotion to the post of Technician-III (Pay Level-2) against 25% LDCE quota about educational qualification "as laid down in the Apprentices Act" should be taken as one of the educational qualifications (trade qualifications, to be more specific) given in the Schedule-I of the Apprentices Rules, 1992 and as amended from time to time, unless specifically mentioned atherwise.

Unified Pension Schome under NPS has been operationalized on IR since 1.4.2025. This scheme envisages that the exercise of option in respect of an eligible employed to be covered under UPS, shall be undertaken: - (i) within three months from 1st April 2025, or within such extended timelines if any, allowed by the Central Government, in respect of a person mentioned under clause (ii) and clause(iii) of sub-regulation (1); and (ii) within thirty days, from the date of joining Central Government services or within such extended timelines, if any, allowed by the Central Government, in respect of a person mentioned under sub-clause (ii) of sub-regulation (1) (3) The option once exercised shall be final and irrevocable.

- Accordingly, the contributions of the employees who have opted for this scheme shall have to be deducted from their safary bills. For this purpose, DDOs and PAOs have to be identified at field units over IR and their roles have to be clearly defined.
- 3. Ministry of Finance has been holding regular meetings to review the progress with regard to implementation of UPS scheme under NPS. During these meetings, it was emphasized that processing of online request and physically received requests shall be regularly monitored. In this connection all the DDOs of Personnel department who have not yet login the Protean NSDL Portal for processing the online requests are advised to process the same at the earliest as well as adhere the following instructions as under-
- All DDOs of Personnel Department shall invariably login on the Proteso NSDL Portal.
- ii) All DDOs of Personnel Department shall make suitable arrangements to process online? off-line requests for Registration of New employees, Migration of existing employees and settlement of past retirees' cases in conformity with the UPS Provisions.
- iii) It shall be ensured that all such cases which have been initiated on NSDL Portal or otherwise are processed as per timelines stipulated from time to time.
- iv). A suitable mechanism may be put in place for monitoring them.

Federation (AIRF) vide their PNM Item no. 20/2024 under reference raised the issue regarding mutual transfer of staff working in Level-I (GP Rs. 1800) belonging to different codres/departments federation has pointed out that some Zonal Railways are interpreting the instructions issued vide Board's letter dated 06.07.2018 (RBE No. 59/2018) in such a way that they are permitting requests of mutual transfers only in cases of inter Division and/or inter Railways.

- 2. The matter has been examined in Board's office. It is clarified that the instructions issued vide REE No. 99/2018 stipulate mutual transfers from one Office/Division/Railway/Unit to another Office/Division/Railway/Unit either in the same or corresponding cadres. In view of the instructions of RBE No.99/2018 and the intentions thereof and the provisions of the Rule-103(51), Chapter-1 of R-1 (The Indian Railway Establishment Code (Volume-I), Fifth Edition (Third Reprint) 2008, envisaging that transfer involves either taking up of duties of a new post or is a consequence of a change of a railway servent's headquarters, it cannot be construed that a mutual transfer is permissible only when a change of Division or Railway is involved.
- 3. The Railways/PUs are therefore advised to process mutual transfer requests, where change of Divisions or Railways is not involved, accordingly.
