In continuation to this office letter of even number dated 28.04.2025, it is stated that following candidates have come out successful in the subject CBT, conducted by RRB/Ajmer on 04.05.2025(Main Examination '1'), 18.05.2025 (Main Examination '2') & on 01.06.2025 (Supplementary examination) to be called for the viva-voce test as per the attached Lists (A) (B) & (C). The candidates named in the above three lists are in alphabetical order. The inter-se seniority is as already circulated vide this office notification of even no. dated 16.01.2025.

The said candidates may please be informed that they should be in readiness to be called for viva-voce test for the subject selection at a very short notice. The time and venue of the viva-voce test will be informed subsequently. Candidates at Sl.No.1 to Sl.No. 6 of the attached List (B) ibid are called to appear in the viva-voce test on relaxed standards as permissible for SC/ST candidates for consideration as In-service Trainees in terms of Railway Board's RB No.57/95 and RBE No.119/89. Candidates at Sl.Nos.1 & 2 of the attached List (C) ibid are called to appear in the viva-voce test on relaxed standards as PwBD candidates in terms of RBE No.133/2023.

2. In terms of Para 206.2 of IREM (Vol.I, 1989 Ed.), Group-C employees qualifying in the selection for promotion to Group-B posts would be required to pass the prescribed medical standard. Only those who qualify in the medical examination of prescribed standard shall be called for viva-voce. It may please be ensured that all the above-mentioned candidates under your control are sent for the prescribed Medical Examination and the Medical Reports of the candidates are sent to CAO/Admn (Secret/Confdl Cell) by 23.07.2025, positively. Medical Memo issued by Medical Department should mention the term 'Fit/Unfit in Gr. 'B' for the post of AFA' as per Para 530 of IRMM.

3. The service records, complete in all respects, of the concerned candidates under your control should be forwarded to CAO/Admn (Secret/Confdl Cell) by 25.07.2025, positively under sealed cover through special messenger. It is advised that APARs for the years 2019-20, 2020-21, 2021-22, 2022-2023 and 2023-2024 in respect of the listed candidates should be sent.

4. Whether there is any D&AR case pending against the candidates mentioned under LIST-A, LIST-B & LIST-C ibid should also be indicated separately and sent to AFA/Admn in a sealed cover by the above-mentioned date. While forwarding the said D&AR clearance, it may also be invariably indicated whether any of them is under Suspension, or any Departmental proceedings have been initiated by issue of a Charge-Sheet or the Railway Servant is facing any prosecution.

Further, it is also requested to obtain **declaration on pendency of criminal case**, if any, from the concerned candidate as per the proforma prescribed in terms of CPO/ER's letter No.E/GAZ/Misc/Policy Dated 01.09.2017 (copy enclosed) and arrange to forward the same to **AFA/Admn** by the above-mentioned date for further action at this end.


5. In case of candidates belonging to PwBD category, copy of PwBD certificate duly attested by concerned unit along with necessary entry and certification of verification from concerned medical authority should be available in the Service Record.

6. The candidature of the candidates mentioned in the list (A), (B) & (C) in the viva-voce test has been accepted **provisionally**. If any candidate is subsequently found ineligible at any stage of the selection, his/her name will be liable to be deleted without further notice.

Sub : Regarding promotion in the Gazetted cadre:
Declaration from the Railway employee/officer.

At the time of promotion from Group-'C' to Group-'B', Group-'B' to Group-'A' and within Gr.'A', DA/SPE/VIG clearances are obtained from concerned Office/Department, but there is no mechanism to know whether any criminal case is pending against the concerned Railway employee/officer in any Hon'ble Court of Law other than on account of any vigilance/CBI investigation/administrative reason.

In such cases, it is required for our knowledge:

- (i) Whether any criminal case is pending against the concerned Railway employee/Officer.
- (ii) If any criminal case is pending against him/her, whether charge-sheet has been issued by the concerned Police/Investigating authority in the said criminal case.

A self declaration in the following format should be taken from the concerned employee/officer.
