

In terms of Railway Board's RBE No. 96/2024, 115/2024 and PCPO/ER/Korkata's Serial Circular no. 117/2024 and 143/2024 respectively and letter no.E. 368/0/Reengagement dated 08.01.2025, applications are hereby invited from retired interested Supervisory employees of TRS/ELS for engagement as the above mentioned categories under the scheme of 'Re-engagement of Retired staff of Electrical (TRS/ELS) Department of Howrah Division.

Annexure-A. The duly filled application along with all relevant enclosures should be sent to 'The Senior Divisional Personnel Officer, Howrah Division, Eastern Railway, Howrah (West-Bengal), PIN-711101 in an envelope within 26.09.2025 up to 18:00 hrs after which no applications will be accepted. Any delay in postal delivery will be the responsibility of the applicant, and applications received after the deadline will not be considered.

- 1. A designated committee will assess the suitability and competency of the retired employee before re-engagement and the Committee's decision will be treated as final and binding. Re-engaged employees should be free from DAR/Vigilance cases
- 2. Integrity aspects of the applicant will be thoroughly checked before approval of re-engagement.
- 3. Employees who retired under the Safety Related Retirement Scheme (SRRS) or the Liberalized Active Retirement Scheme for Guaranteed Employment for Safety Staff (LARSGESS) are not eligible for re-engagement.
- 4. Employees who were removed, dismissed, or retired compulsorily are not eligible.
- 5. Retired railway employees found suitable/competent will be re-engaged after obtaining medical fitness applicable to the categoryi.e., A3 from designated authorities as per existing practice.
- 6. Re-engagement will be in the same pay level as held at the time of retirement.
- 7. Engagement will be decided based on job requirement and individual suitability. The committee will take in account the working experience of staff so that they are useful for the purpose for which they are selected.
- 8. The upper age limit for re-engagement is 65 years as on date of notification.

#### Remuneration and Allowances (As per RBE No. 96/2024):

- a) A fixed monthly remuneration will be paid, calculated by deducting the basic pension from the last drawn pay at the time of retirement. This amount of remuneration so fixed shall remain unchanged during the term of the contract.
- b) No increment, Dearness Allowance (DA), or House Rent Allowance (HRA) will be admissible.
- c) An appropriate and fixed amount as Transport Allowance for the purpose of commuting between the place of residence and work shall be allowed, not exceeding the rate applicable at the time of retirement. This amount will remain unchanged during the engagement period. However, they may be allowed TA/DA on official tour, if any as per their entitlement at the time of retirement.
- d) Paid leave of absence will be granted at the rate of 1.5 days for each completed month of service. Leave accumulation beyond a calendar year is not permitted.

#### 9. Duration of Engagement:

- The re-engagement scheme remains in vogue for an initial period of <u>02 (two)</u> years from the date of issue of instructions or till further orders, whichever is earlier.
- Engagement period of an individual retired staff will be for a period of <u>01(one)</u>
   year or till further orders, whichever is earlier. However based on satisfactory

performance, the period of engagement may be extended for one more year or until the employee attains 65 years of age, whichever is earlier.

### 10. Termination Upon Joining of Regular Staff:

 Re-engaged employees will be relieved immediately upon the joining of newly selected/promoted employees.

### 11. Termination on Grounds of Performance:

 Engagement may be terminated at any time for unsatisfactory service, without following any formal procedure.

#### 12. Preference Criteria:

- Eligible retired SSE/JE will be considered but preference will be given to those who retired within 90 days prior to the first date of re-engagement.
- 13. Age and educational qualifications will be determined based on service records.
- an imployees re-engaged should be willing to work anywhere in the concerned Unit.
- 45. Working hours will be in accordance with the assigned category and operational requirements.
- 16. The decision of the administration regarding acceptance or rejection of applications will be final.
