Existing Clause

16.5 (i) All reinforcement are to be used, shall only be these manufacturer by one of the following firms

- i) SAIL
- ii) TISCO
- iii) IISCO
- iv) RINL

Proposed Clause

16.5(i)(a) All reinforcement Steel (TMT Bars) and Structural Steel shall be procured as per specifications motioned in BIS's documents – IS:1786 and IS:2062 respectively. Independent tests shall be conducted, wherever required, to ensure that the materials procured conform to the Specifications.

- (b) These steel shall be procured only from those firms, which are Established, Reliable, Indigenous & Primary Producers of steel, having integrated steel plants (ISP), using iron ore as the basic raw material and having in-house iron rolling facilities, followed by production of liquid steel and crude steel, as per Ministry of Steel's guidelines.
- (c) However, only certain isolated sections of structural steel, not being rolled by ISPs, can be procured from the authorized re-rollers of ISPs or authorized licensee of BIS having traceability system and who use billets produced by ISPs. Traceability shall be ensured by an officer specially authorized by the concerned SAG Officer of the Zonal railway on case to case basis for this purpose.
- (d) Following firms/plants wilf be considered qualifying the criteria given in 16.5(i) (b).
- i) SAIL Plant at Bhilai/Durgapur/Bokaro/Rourkella
- ii) TISCO Plant at Jamshedpur
- iii) IISCO Plant at Burnpur
- iv) Alloy Steel Plant Plant at Durgapur
- v) Visheswaria Iron & Steel Ltd. Plant at Bhadravati, Karnataka
- vi) RINL Plant at Vishakapattnam.
- vii) JINDAL-Plant at Raigarh.

16.5(ii) All paints/distemper/plastic paints to be used shall only be these manufactured by one of the following firms or any approved brand and of colour and shade approved beforehand by the Engineer-at site
