

Attention is invited to Board's letter of even number dated 25.08.2015 whereby Railway's were advised to keep in abeyance the payment of Transport Allowance @7000/- p.m. +DA thereon, to IRMS officers drawing Grade Pay of Rs. 10,000/- under DACP Scheme has been communicated. Against this decision, IRMS Association has filed an O.A. (No. 3528/2015) before CAT/New Delhi and the Hon'ble Tribunal vide their order dt. 27.10.2015 have given interim stay against reduction of Transport Allowance @ 7000/- p.m. + DA thereon in respect of IRMS officers.

2. In compliance of the aforesaid order of Hon'ble Tribunal, New Delhi, it is advised that payment of Transport Allowance to IRMS officers @ 7000/- p.m. + DA thereon, may be continued till further orders from Board's office.
