Copy of Railway Board's letter PC-V/2009/ACP/2, S.No.PC-VI/360 dated 23.11.2015(RBE No. 147/2015) addressed to the GM (P)/ All Indian Railways and others.

Sub: Modified ACP Scheme (MACPS) for Railway employees - clarification - regarding.

Reference is invited to para 2(i) of Board's letter of even number dated 31-01-2013 (RBE No. 08/2013) regarding regulation of MACP Scheme in cases involving unilateral transfer on own volition to a lower post in another unit/organization after earning a promotion in previous organization. This issue has been raised in PNM Forum by AIRF as item No. 26/2013 and it has been agreed to circulate DoP&T's instructions contained in para 2(i) of their OM dt. 04.10.2012 as it is. The instructions contained in para 2(i) of DoP&T's said OM are reproduced below:-

" This Department's OM No. 35034/3/2008-Estt.(D) (Vol.II), dt. 01.11.2010 provides that in case of transfer ' including unilateral transfer on request', regular service rendered in previous organization / office shall be counted along with regular service in the new organization /office for the purpose of getting financial upgradations under the MACP Scheme. However, financial upgradation under the MACP Scheme shall be allowed in the immediate next higher grade pay in the hierarchy of revised Pay Bands as given in Railway Services (Revised Pay) Rules, 2008. **It is now further clarified that wherever an official, in accordance with terms and conditions of transfer on own volition to a lower post, is reverted to the lower Post / Grade from the promoted Post / Grade before being relieved for the new organization / office, such past promotion in the previous organization / office will be ignored for the purpose of MACP Scheme in the new organization /office".**

2. The instructions issued on MACP Scheme vide para-2(i) of Board's letter of even number dt. 31.01.2013 stands modified to the above extent.
