As you are aware Department of Pension and Pensioners' Welfare has devised a platform whereby retiring government servants have an option to upload a write-up of not more than 5000 words showcasing outstanding work done during the service alongwith appropriate attachments, wherever necessary, on the website of the department from where the official retires and the website of the cadre controlling authority. DOP&PW's OM No.4/2/2013-P&PW(Coord.)dated 19.02.2015 and OM 4/2/2014-P&PW(Coord)dated 5.3.2015 may be seen in DOP&PW's official website <http://persmin.gov.in>.


Instructions in this regard has been circulated vide letter of even number dated 27.3.2015 followed by letters dt.21.5.2015 and 16.6.2015.


As may be seen till date only 50 write-ups have been published on the "Anubhav" Portal. In the meeting on "Anubhav" by DOP&PW on 10th July,2015 the progress of uploading and publishing of write-ups by retiring employees was reviewed. It has been pointed out that more retiring employees as well as employees of attached/subordinate offices be encouraged to participate in "Anubhav" as this project is being monitored at the highest level. Assistance to the lower functionaries may be given by officers and Welfare Inspectors so as to encourage them to showcase the outstanding work done by them during service. Even staff who have retired in the last one year can be encouraged to share the "Anubhav". DOP&PW is very keen that this Compendium of experience be available for others to share and benefit.

It is requested that wide publicity should be given so that the instructions are circulated amongst all employees as well as attached/subordinate offices for encouraging more employees for participation in "Anubhav" Scheme.
