

Sub: Courses for staff other than those involved in train passing/operation duties-Age limit for exemption from undergoing the Refresher Training.

Kindly refer to Board's letter No. E(Trg)-75(30)/10 dated 11.09.1975 wherein it had been decided that the staff who are of the age of 55 years and above, who are not employed in training operation/ train passing duty should be exempted from undergoing the prescribed Refresher Courses (copy enclosed).

Keeping in view that the retirement age has been raised from 58 to 60 years, the age limit of 55 years laid down vide Board's letter stated above is increased to 57 years, in respect of staff not employed in train operation/train passing duty.

All other conditions mentioned in the Board's letter dated 11.09.1975 remain unchanged.

विषय: गाड़ी पास करने /ऑपरेशन ड्यूटियों में शामिल कर्मचारियों से इतर कर्मचारियों के लिए पाठ्यक्रमों के संबंध में पुनश्चर्या प्रशिक्षण प्राप्त करने के लिए आयु सीमा में छूट देना।

कृपया बोर्ड का दिनांक 11.09.1975 का पत्र सं. ई (ट्रेनिंग)75(30)/10 देखें जिसमें यह विनिश्चय किया गया था कि जो कर्मचारी 55 वर्ष या इससे अधिक आयु के हैं, जो ट्रेनिंग ऑपरेशन/गाड़ी पास करने पर नहीं लगाए गए, को निर्धारित पुनश्चर्या पाठ्यक्रम से छूट दी जाए (प्रतिलिपि संलग्न है)।

इस बात को ध्यान में रखते हुए कि सेवानिवृत्ति की आयु 58 वर्ष से बढ़कर 60 वर्ष हो गई है अतः बोर्ड के उपर्युक्त पत्र में ट्रेन ऑपरेशन/ गाड़ी पास करने की ड्यूटी पर न लगाए गए कर्मचारियों के संबंध में निर्धारित 55 वर्ष की आयु सीमा बढ़ाकर 57 वर्ष की जाती है।

बोर्ड के दिनांक 11.09.1975 के पत्र में उल्लिखित अन्य सभी शर्तें अपरिवर्तित रहेंगी।

The Railway Board have had under consideration the question of whether any age limit should be laid down for booking the staff for undergoing the prescribed Refresher courses. They have now decided that the staff of and above the age of 55-years who are not employed in train operation/train passing duties should be exempted from undergoing the prescribed Refresher Courses, and therefore, they need not be booked for these courses.
