

Copy of CMD, E. Railway's letter No. MD.173/0/Policy dated 19.09.16 addressed to the CPO, Eastern Railway.

Sub: Communication of "REASONS FOR UNFITNESS" to unfit (medical)  
candidate.

It is to intimate that as per usual practice, on the basis of appeal, the re-medical examination of candidate (non-Gazetted) is conducted by three member committee headed by CMSs of the respective hospitals.

In this regard, it is appraise that to keep transparency of the total procedures of medical examination of any candidate (non-Gazetted), it is reiterated that as per this office letter no. MD.173/0/Policy dated 16.10.14, on conducting medical examination, if any candidate is found to be unfit for the specified Medical Category; the same is supposed to be intimated to the said candidate regarding the "REASONS FOR UNFITNESS" as accepted by CMS of the said hospital.

In this connection, it is requested that the reasons for unfitness as stated should be intimated to the candidate in the form of "SPEAKING ORDER". It is also to be communicated to the candidate regarding the provision of appeal (as given in Para-VIII A&B of Rly. Bd's letter dt.31.12.15) for re-medical examination on depositing of Rs.1000/ (Rupees one thousand) only through Demand Draft. For convenience of the candidate, it is required to be mentioned in the communicating letter, regarding the name of the "ADDRESSEE" for drawing the Demand Draft of Rs.1000/- for depositing the money which is essential for consideration of the said appeal by the competent authority.

It is also to state that the candidate should be apprised that his/her appeal shall be entertained only if the candidate produced a certificate from a Govt./Private doctor of the speciality in which the candidate has been found unfit and such a certificate should also contain the note that the Govt/Private specialist was aware of the fact that the candidate has already been declared unfit during medical examination conducted by a appropriate medical committee appointed by the Govt. in this regard.

Necessary action may please be taken for communicating the same to all the Sr. DPOs & WPOs of Eastern Railway to avoid any ambiguity and/or double procedure in taking proper procedure for communicating the decision of divisional three member committee to any candidate (non-Gazetted) in case of re-medical examination.
