
PFRDA has made it mandatory to provide the bank details at the time of submitting the subscriber registration form to CRA-FCs after 31.03.2013. Accordingly, the subscriber registration form S1 has been modified. A copy of the same is enclosed herewith for further necessary action at your end.

Further, NSDL has also intimated that the Statement of Transactions (SOTs) for the period from 01.04.2011 to 30.09.2012 have been dispatched to the IRA compliant subscribers at their correspondence address and that of the non-IRA compliant subscribers to the associated PAOs for onward distribution to the subscribers. The following salient points about the information displayed in SOTs may be noted so that the NPS cells are equipped to handle queries, if any, raised by the subscribers pertaining to SOTs:

- SOT has been sent for all subscribers registered in CRA system till 31.03.2012 and active as on 30.09.2012.
- The contribution of a subscriber, if any, force matched during the said period (but pertaining to earlier period) have also been included in the SOT.
- SOT has been sent for all subscribers irrespective whether the subscriber has holdings in his/her account or not.
- For certain identified cases of duplicate/multiple PPANs, modification of contribution type and period, SOTs have not been dispatched. The online SOT is also not available for these subscribers. Once transactions are updated, based on the clarification received from the PrAO/PAO, SOTs will be made available online. It is thus necessary to finalise these cases at the earliest.
- The SOTs dispatched has four separated blocks:
 - Block A (Accumulated contribution upto 31.03.2011): This block shows contribution accumulated - match and booked for the subscriber till 31.03.2011.
 - Block B (Regular Monthly Contribution): This block contains regular monthly contribution matched and booked during the statement period. The 'Regular transactions (appearing in Block B of SOTs) have been sorted on the basis of 'Contribution month and year and then on NAV date'.
 - Block C (Arrear Contribution): This block contains arrear contribution matched & booked during the statement period. The transactions 'arrears' (appearing in Block C of the SOT) have been sorted on the basis of the NAV date i.e. date of investment for contributions.
 - Present Value of Total Contributions: This block summarized investment made and displays current valuation of investment.

Kindly have these instructions circulated to all concerned for information and necessary action.
