



As, the minimum service required on the Railway for Inter-Railway/Divisional transfer has been reduced to 5 years from 10 years, vide Board's letter No. 2011/E(Sports)/4(3)/4(Transfer Policy) dt. 17.02.2011; the Para 3(iv) of Annexure-V to Board's policy letter referred above, may be revised and the word "ten" as mentioned in second line of said para, be replaced with "five".
