2. It is also stated that further notification inviting application from the pre-2006 pensioners/family pensioners as well as details of Help Desk formed in division/workshop for providing information to the pensioners/family pensioners have been published in all leading news papers.

3. Therefore, special efforts are required to be taken for completion of revision works through pension cell at the earliest.



Consequent upon DOP & PW's OM No. 38/37/08-P & PW(A) dt. 28.01.2013 and 13.02.2013 circulated through Rly Bd's letter No. F(E) III/2008/PN1/12 dt. 11.02.2013 and No. 2013/AC-II/21/1/ dt. 17.04.2013 regarding revision of pension of Pre-2006 pensioners following are decided:

1. Where revision has been done by Railway Administration as per recommendation of VIth CPC on the basis of the sanction of the competent authority.

Following action may be taken by the Accounts Offices without further sanction of the executive authority.

- i) Pensioners in scales which have no effect as per DOP & PW's OM dt 28.01.2003 referred above – a 'no change' reply may be sent to the applicants.
- ii) Pensioners in scales which have effect as per DOP & PW's OM No. 38/37/08-P & PW(A) dt. 28.01.2013 referred to above should be reviewed and action should be taken as follows on suo-motu basis :-
 - a) If pension/family pension does not increase, revised authority need not be issued, only a "no change" reply may be given to the applicant.
 - b) If pension/family pension increases, a revised authority duly showing the pension, enhanced family pension (if applicable) and normal rate of family pension w.e.f. 01.01.2006 as well as 24.09.2012 should be issued and Pension Master should be up-dated.
 - c) Where revision has been done on suo-motu basis but revised PPA was not issued due to want of updated particulars of Pensioners and disbursing authorities, Pension Master need to be updated but revised authority will be issued after getting the same from pensioner or disbursing authority etc.

2. Where revision as per recommendation of 6th CPC has not been done yet due to want of updated particulars of the pensioner and disbursing authority.

Revision of all remaining cases has to be done jointly by the sanctioning authority and associated accounts offices in accordance with DOP & PW's O.M. No. 38/37/08 PW(A) dated 01.09.2008, 28.01.2013 and others issued from time to time after receipt of data from Pensioners/Disbursing authorities. Revised PPAs should be issued showing clearly the revised basic pension, Enhanced family pension, normal rate of family pension as applicable w.e.f. 01.01.2006 as well as 24.09.12 simultaneously and pension master data has to be updated in HQ/IT Centre.

3. It should be clearly indicated in the revised PPA that the arrear arisen out of upward revision of pension/family pension due to DOP & PW's OM dated 28.01.2013 will be payable w.e.f. 24.09.2012 only.
4. Revised PPA should show the last pay scale; corresponding pay scale in 3rd CPC, 4th CPC, VIth CPC (as applicable), VIth CPC and grade pay, minimum pay in the pay scale as per fitment table.
