

OFFICE MEMORANDUM

Subject: Grant of Dearness Relief to Central Government pensioners/family Pensioners- Revised rate effective from 01.01.2011.

The undersigned is directed to refer to this Department's OM No.42/18/2010-P&PW (G) dated 27th September, 2010 on the subject mentioned above and to state that the President is pleased to decide that the Dearness Relief (DR) payable to Central Government Pensioners/Family Pensioners shall be enhanced from the existing rate of 45% to 51% w.e.f. 1st January, 2011.

2. These orders apply to (i) All Civilian Central Government Pensioners/Family Pensioners (ii) The Armed Forces Pensioners, Civilian Pensioners paid out of the Defence Service Estimates, (iii) All India Service Pensioners (iv) Railway pensioners and (v) The Burnas Civilian pensioners/family pensioners and pensioners/families of displaced Government pensioners from Pakistan, who are Indian Nationals but receiving pension on behalf of Government of Pakistan and are in receipt of ad-hoc ex-gratia allowance of Ru.3500/- p.m. in terms of this Department's OM No.23/1/97-P&PW(B) dated 23.02.1998 read with this Department's OM No.23/3/2001-P & PW(B) dated 15.09.2008.

3. Central Government Employees who had drawn lump sum amount on absorption in a PSU/Autonomous body and have become eligible to restoration of 1/3rd commuted portion of pension as well as revision of the restored amount in terms of this department's O.M No.4/59/97-P&PW(D) dated 14.07.1998 will also be entitled to the payment of DR @ 51% w.e.f. 01.01.2011 on full pension i.e. the revised pension which the absorbed employee would have received on the date of restoration had he not drawn lump sum payment on absorption and Dearness Pension subject to fulfillment of the conditions laid down in para 5 of the O.M. dated 14.07.1998. In this connection, instructions contained in this Deptt's O.M. No.4/29/99-P&PW(D) dated 12.07.2000 refer.

4. Payment of DR involving a fraction of a rupee shall be rounded off to the next higher rupee.
