




Copy of Railway Board's letter No. 2010/ E(Sports)/ 4(1)/ 1/ Policy dated 11th. March, 2011 (RBE No. 34A/2011 - Clarification/Corrigendum No.7) addressed to GM(P) All Zonal Railways & Others.

Sub: E(Sports) Policy letter No. 2010/E(Sports)/4(1)/1 Policy.

In the wake of a reference received in this office regarding para 3.1.4 of this office policy letter dated 31.12.2010 to amend the policy the matter has been considered by Board and it has been decided that applications for all eligible sports persons for the nominated games should be collected by Personnel Department either directly or from Sports Department. Every such collected application of all eligible sports persons should be registered in a proper format in the assigned register.

2. Besides it has also been decided that no open advertisement quota should be converted to Talent Scouting quota as there is already an indication from Vigilance Directorate to discourage Talent Scouting Scheme.
3. Downgradation of posts should be done only with the permission of Railway Board after due justification from respective railways.

All units are requested to act accordingly.
