

Attention is invited to Board's letter of even number dated 19.11.2008 under which Cabinet Secretariat's order dated 26.09.2008 constituting a Complaints Committee to inquire into the complaints of sexual harassment against officers of the level of Additional Secretaries and Secretaries to the Government of India had been circulated. Cabinet Secretariat have now issued further orders bearing No. 501/IV/4/2010-VCC dated 09.11.2011 inter alia extending the tenure of the Complaints Committee for a period of 3 years w.e.f. 26.09.11. A copy of the orders dated 09.11.2011 aforesaid is also enclosed.

Cabinet Secretariat's ORDER No. 2 bearing No. 501/IV/4/2010-VCC dated 09.11.2011 issued by Secretary (Co-ordination & PG) addressed to All Ministries/Departments of Government of India and others.

Sub:- Reconstitution and extension of members of the Complaints Committee to enquire into complaints of sexual harassment against Additional Secretaries and Secretaries to the Government of India.

A Complaints Committee to enquire into complaints of sexual harassment made against officers of the level of Secretary and Additional Secretary and equivalent level in Ministries, Departments and organizations directly under the control of the Central Government other than Central PSUs was constituted by the Cabinet Secretariat vide F. No. 501/28/1/2008-CA V dated 26-09-2008 for a period of three years w.e.f. 26-09-2008. With the approval of the Prime Minister, it has been decided to extend the tenure of the Complaints Committee for a period of three years w.e.f. 26-09-2011. It has also been decided to appoint Ms Anju Talukdar, Executive Director, MARG, New Delhi as a member of this Committee.

2. The composition of the Committee will, therefore, be as follows:

1. Ms. Rathi Vinay Jha, Retired Union Tourism Secretary - Chairperson
2. Ms. Indu Agnihotri, Senior Fellow, Centre for Women's Development Studies - Member
3. Ms. Anju Talukdar, Executive Director, MARG, New Delhi - Member
4. A senior officer with experience of the sector or department to which the complaint relates (to be nominated for each case separately depending upon the Department/Ministry to which the complaint relates) - Member

3. The Committee will proceed in accordance with guidelines laid down by the Supreme Court in the case of Visakha and Others vs. State of Rajasthan and will be serviced by the Cabinet Secretariat.
