



Vide Board's letter No. 93/E (GR)II/9/1 dated 15/02/1993, it was decided to raise the age limit of candidates at the entry level for appointment as Contract Medical Practitioners from below 30 years to 50 years. Further, in terms of Board's letter No. 2013/E (GR)II/1/5 dated 20.05.2014, the number of annual terms of engagement of Contract Medical Practitioners was enhanced from 8 terms to 10 terms on year to year basis with each term of engagement not being more than one year each.

2. The matter regarding maximum age limit and increasing the annual terms for engagement of Contract Medical Practitioners was under consideration of this Ministry for quite some time and it has now been decided that the number of annual terms for engagement of CMPs is enhanced from the 10 terms to 12 terms on year to year basis or till attaining the age of 60 years whichever is earlier, and each term of engagement shall not exceed more than one year.

3. All other terms and conditions as laid down in Railway Board's letter No. 96/E (GR)II/9/16 dated 23.2.2000 and as amended from time to time shall remain unchanged.

4. This issues with the concurrence of the Finance Directorate of the Ministry of Railways.


