Ministry of Railways have reviewed the rate of remuneration payable to Medical Practitioners engaged on contract basis (CMPs) laid down in Railway Board's letter No. 2014/E(GR)II/1/1 dated 12.03.2014. It has been decided to revise the monthly remuneration payable to CMPs engaged on full time basis on Railways, as under:-

Category of CMPs	Monthly Remuneration (in ₹)
GDMO	60,000/-
Specialist (1 st Year)	70,000/-
Specialist (2 nd Year onward)	80,000/-
Super Specialist	90,000/-



4. This issues with the concurrence of the Finance Directorate of the Ministry of Railways.




