Sub: Admissibility of Deputation(Duty) Allowance while on deputation beyond 5th year.

Consolidated guidelines on 'Deputation' have been issued by DOP&T vide their O.M. No. 6/8/2009-Estt.(Pay-II) dated 17.06.2010 & No. 2/6/2016- Estt.(Pay-II) dated 17.02.2016 which have been adopted/circulated on the Railways vide Board's letter dated 28.07.2010 & 21.04.2016 respectively.

2. Further, DOP&T in the context of their O.M. No. 2/6/2016- Estt.(Pay-II) dated 17.02.2016 [wherein, powers were delegated to Ministries/Deptt. Borrowing organisations to extend deputation tenure upto a period not exceeding seven (7) years at a stretch] have reiterated vide their O.M. No. 2/6/2016- Estt.(Pay-II) dated 23.02.2017 that deputation (duty) allowance is admissible only upto the 6th year, if the deputationist has opted to draw deputation (duty) allowance.

3. A copy of these instructions is sent herewith for information guidance. These will apply mutatis-mutandis to Railway employees also.



कार्मिक एवं प्रशिक्षण विभाग के दिनांक 17.06.2010 के का.जा. सं.6/8/2009 -ईस्ट.(पे-II) एवं दिनांक 17.02.2016 के सं.2/6/2016-ईस्ट.(पे-II) के तहत 'प्रतिनियुक्ति' के संबंध में समेकित दिशा-निर्देश जारी किए गए हैं, जिन्हें बोर्ड के क्रमशः दिनांक 28.07.2010 और 21.04.2016 के पत्र के तहत सभी रेलों में लागू भी किया गया है।

इसके अलावा, कार्मिक एवं प्रशिक्षण विभाग ने दिनांक 17.02.2016 के का.जा. सं.2/6/2016-ईस्ट (पे-II) के तहत प्रतिनियुक्ति कार्यकाल को लगातार अधिकतम सात (7) वर्ष की अवधि तक बढ़ाने के लिए (व्यवस्थापक विभागों/उधार लेने वाले संगठनों को शक्तियाँ दी गई थी) के संदर्भ में उन्होंने दिनांक 23.02.2017 के का.जा. सं.2/6/2016-ईस्ट.(पे-II) में यह दोहराया कि यदि प्रतिनियुक्ति पदधारी ने प्रतिनियुक्ति (इयूटी) लेना लेने का चयन किया है, तो प्रतिनियुक्ति (इयूटी) भत्ता केवल पाँच वर्ष तक ही स्वीकार्य होगा।



OFFICE MEMORANDUM

Subject: Admissibility of Deputation (Duty) Allowance while on deputation - regarding.


The undersigned is directed to refer to this Department's O.M. of even number dated 17th February 2016 vide which powers were delegated to Ministries / Departments / borrowing organisations to extend deputation tenures up to a period not exceeding 7 years at a stretch, in respect of cases covered by the O.M. dated 17th June 2010.

1. The matter regarding the admissibility of Deputation (Duty) Allowance in view of the change in maximum number of years of deputation tenure as provided above has been examined in this Department.

2. As per Para 8.3.2 of the OM No. 6/8/2009-Estt.(Pay-II) dated 17th June 2010, where the extension is granted up to the fifth year, the official concerned will continue to be allowed Deputation (Duty) Allowance, if he/she has opted to draw deputation (duty) allowance.

3. This Department's O.M. No. 2/6/2016-Estt.(Pay-II) dated 17th February 2016 delegates powers to Ministries / Departments / borrowing organisations, to extend deputation tenures up to a period of 7 years in a stretch, in respect of cases covered by the O.M. dated 17th June 2010. However, there has been no modification of the Para 8.3.2. of the O.M. dated 17th June 2010 by the O.M. dated 17th February 2016. The new O.M. dated 17th February 2016 provides vide Para 4 that all other terms and conditions issued vide OM No. 6/8/2009-Estt.(Pay-II) dated 17th June 2010 will remain unchanged.

4. Thus, admissibility of Deputation (Duty) Allowance would be only as per Para 8.3.2 of the O.M. dated 17th June 2010, i.e. **only up to the fifth year**, if the deputationist has opted to draw Deputation (Duty) Allowance.
