

Sub:- Exemption from the provision of Railway Act, 1989 in respect of Track Machine Staff.

Attention is drawn to Board's letter of even number dated 09.09.2009 granting temporary exemption for 3 year s i.e. up to 08.09.2012 from the provisions of Railway Act 1989 for introducing three weeks' roster at a stretch followed by continuous rest of one week at the Headquarter in respect of the staff operating track machines.

The matter has been examined in consultation with Ministry of Labour & Employment and it has been agreed to grant exemption for a further period of three year s w.e.f. 09.09.12 till September ,2015 with the same condition that the three week' work at a stretch will include the journey period utilized by the workmen in respect of journey conducted by him from the duty point to his Headquarters followed one week rest.
