Railway Board vide their letter no. 2014/E(Sports)/5(2)/16 dated 31.07.17(copy enclosed for ready reference) has asked to furnish a list of all pending cases of incentive increments to sportspersons for their recognized sports achievements before 2010, who were eligible as per policy in vogue at the time of their sports achievements in reference to Rly. In view of the above, necessary action may please be taken for preparing a list of sportspersons/coaches under your control relating to such pending cases of incentive increments, as mentioned above, and the same may be sent to this office along with applications of the candidates enclosing attested copies of relevant sports certificates indicating their names, disciplines of sports, present designation and present place of posting.

The above list may please be sent to this office within 06.09.17, so that the same may be processed for forwarding to Railway Board within 15.09.17, otherwise it would be presumed that there is no such pending cases and no proposal in this regard will be entertained by Railway Board after the due date.



2) This office letter of even no. 2014/E(Sports)/5(2)/16 dated 28.01.2015.

Vide this office letter under reference, all Indian Railways/Units were requested to furnish the details of all pending cases of incentive increments to sportspersons for their recognized sports achievements, who were eligible as per policy in vogue at the time of their sports achievements, along with proposal for Board's approval with all relevant information, documents, financial implications and reasons for delay latest by 06.02.2015.

Only few requests for grant of such incentives have been received from Sports Associations directly and not through the personnel department. Railway Board is still receiving requests from sportspersons/coaches for granting additional increments, which were due to them for their sports achievements before 2010 but have not been given.

It is reiterated that all Zonal Railways/Units may furnish a list of all pending cases of incentive increments to sportspersons for their recognized sports achievements, who were eligible as per policy in vogue at the time of their sports achievements latest by 15.09.2017.

This letter may also be given wide publicity among all present and past sportspersons, coaches etc. The concerned sportspersons may send an advance copy of their requests directly to this office in addition to the one being submitted at their Railway/Unit.

In case of non-receipt of any information/proposal from any ZR/PU, it will be presumed that there is no pending case in their ZR/PU. No individual/ZR/PU's proposal in this regard will be entertained after that.
