- iii) The Jr. Scale revenue post of Secy to PCOM/FP is transferred to SDAH division for its operation as AOM(G)/SDAH .


The re-designations and transfer and operation of posts mentioned in item no A (i), A (ii) and A (iii) have the approval of the General Manager.


