Sub: Holding of Special Camp for differently abled non-gazetted Employee of Eastern Railway.

Eastern Railway/HQ is going to organize a Special Camp for the differently abled non-gazetted employees (42 heads) at Vizag to be held on & from **23.07.2019 to 27.07.2019**. Quotation (including GST) are invited in a Sealed cover within **03.06.2019** for taking further necessary action. Quotation should be dropped in the Box kept at Welfare Section, PCPO's Office, Eastern Railway, 17, N.S. Road, Kolkata-01 by 17.00 hrs on **03.06.2019**. Special Care is required to be given to the Campers being differently abled. While quoting, it should be kept in mind that arrangement of any vehicle should be A.C, hotel accommodation should be in AC Rooms (Double/Triple bed sharing) preferably Ground Floor / first floor with lift facility, packaged drinking water (2 litre) per day for each camper to be provided. Separate Railway Coach will be arranged by Eastern Railway itself. All fooding, lodging,, Vehicles (excluding train) should be borne by Tour operator.
