
Sub : Re-engagement of retired employees in Account Department at HQ Office, Eastern Railway, Kolkata.

Applications are invited from the Retired Railway Employees of Eastern Railway in terms of RBE No.150/2017 & 193/17 for re-engagement of staff in Accounts departments for the following posts.

Terms and conditions for the re-engagement are stated below:-

1. Employees retired from Accounts Department of Eastern Railway are eligible to apply. Preference will be given to those retired from HQ offices.
2. As far as practicable, preference for re-engagement is given to those eligible retired employees, **who have retired within 90 days prior to the first date of re-engagement.** Others are also eligible to apply.
3. **The applicants should only be from the respective cadres** i.e Stenographer, Stock verifiers & Gr.D.(new OAA)
4. Removed/Dismissed /Compulsory/Voluntarily Retired employees are not eligible for re-engagement.
5. Re-engagement will be subject to prescribed medical fitness for the category.
6. Maximum age limit for such re-engagement shall be 65 years. Only those retired staff may apply who will have minimum tenure of 1&1/2 year at the time of filling option form.
7. Monthly remuneration of a retired employee being re-engaged will be determined by **reducing pension from his/her last pay drawn (i.e. Basic Pay + DA).and no other allowance/remuneration shall be payable** in terms of RBE No.150/2017 & 193/17.
8. Suitability/competency of the staff shall be adjudged by a committee nominated for this purpose. Decision of the committee shall be final.
9. The services of such re-engaged employees may be terminated at any point of time for unsatisfactory service without any prescribed procedure.
10. Re-engaged staff will be dis-engaged immediately on joining of selected candidates from RRBs/RRCs against vacant posts.
11. The re-engaged retired staff is liable to be posted at any place of Head quarter unit as per departmental requirement.
12. The duty hours of the re-engaged employees would be as per working conditions of the category/other exigencies.
13. Re- engaged employee will not be eligible for any kind of leave like C.L, L.A.P, Sick Leave etc.
For absence,if any, appropriate deduction will be made from the monthly remuneration.
14. An agreement shall execute with the retired employee to abide by all the terms and conditions of re-engagement.
15. Applications should be addressed to Principal Financial Advisor, Eastern Railway, 17, N.S.Road,Kolkata-700001 and sent by ordinary post or may be dropped in the Box kept in the **Administration Section, Ground floor** on week days within 30 days from the date of notification i.e **within 15.07.2019.**
16. Applications should be made in the proforma annexed as ANNEXURE-A.
17. This scheme is valid up to **01.12.2019** subject to extension by Rly. Board/ or attaining 65 yrs of age/ or joining of selected candidates from RRBs/RRCs against vacant posts whichever is earlier.
