Sub: Release of TA personnel for attending 30 days ATC for 3rd batch of ATC 2019-20 w.e.f. 26.08.2019 to 24.09.2019

Ref: Adm.Officer, 969 TA/JMP's letter No. 1307/987 E&MM Coy/2019-20/G, dated 10.07.2019.

In terms of Railway Board directives the enlisted TA Personnel may please be released and directed to report to Adm. Offr. 969 RLY ENGR REGT TA/JMP on **26.08.19 at 06:00 hrs** for attending 3rd Batch of ATC 2019-20 w.e.f. **26.08.2019 to 24.09.2019** and in case of person earmarked for "ADVANCE PARTY" they are to report to the unit on **19.08.2019 at 06:00 hrs**. Persons earmarked as 'Call for Certificate (CFC)' are called to prepare their discharge certificate only and not to attend Annual Training Camp and they will report on **26.08.2019**.

The concerned staff must have his individual Identity Card along with Grocery Smart Card, three nos colored 03X passport size photograph, Blood Group certificate, proof of present address and designation, Bank's NEFT Mandate form, character certificate duly signed by the superior authority and release letter from his unit concerned when he will join the camp at Jamalpur, extra set of pass including self and family to enable to send to his home and also bring back on termination of the camp and necessary ORS pass on TA duty from their HQ to Jamalpur and back with permissible validity period.

For the duration of absence on ATC the Railway TA Personnel (Transportation Running Staff) should be paid the actual average Running Allowance. TA personnel should also be permitted to draw the actual average overtime, piecework profits and average night allowances.

TA personnel when released for attending ATC are entitled a total 06 days Special CL before/after the training camp in addition to the travel time.


Attendance details in respect of each ATC in prescribed format as per SDGM/ER's letter No. ER/ATC/969/TA Dated 02.05.18, may please be furnished and sent to this office at the earliest so that Rly. Board may be apprised accordingly.

It may also be noted that No TA person should exempt from attending Annual Training Camps without the prior approval of DRM/ADRM/CWM (in rare cases).
