

In pursuance to Honbl'e CAT/Kolkata's order dt.05.07.19 in M.A. Nos. 859/2018 & 431/2019 arising out of O.A. No. 1146/2018 and M.A. Nos. 860/2018 & 432/2019 arising out of O.A. No. 1147/2018, the cancellation order issued under ref. (2) above in response to the notification under ref. (1) on subject selection is hereby nullified and selection initiated against that notification is revived by segregating the RPF candidates from the written tests result. The further course of action to finalise the selection of Chief Law Asstt. against notification dt.21.08.15 (Ref. 1) will be initiated as per directives of Hon'ble CAT/Kolkata.
