Sub : General Selection for formation of panel for 04 posts of Lab Asstt.Gr.II in Level -03 of Pay matrix (Corresponding GP- Rs.2000/-in PB-1) against 50% promotional quota of erstwhile Group 'D' Staff in Level -01 of Pay matrix (Corresponding GP- Rs.1800/-in PB-1) working as Laboratory Attendant in Eastern Railway.(Communal break up : UR- 03, SC-01 & ST- Nil)

To form a departmental panel for the post of Lab Asstt.Gr.II in Level-3 of Pay matrix (Corresponding GP- Rs.2000/-in PB-1) against 50% promotional quota of erstwhile Group 'D' Staff in Level -01 of Pay matrix ( Corresponding GP- Rs.1800/-in PB-1) working as Laboratory Attendant in Eastern Railway, it is proposed to hold a selection comprising of written test of objective type and Scrutiny of S/R & APAR . The examination may be held shortly and no supplementary test will be held. The final date of examination will be circulated separately(IREM Vol-I, item No. 165(i)(ii).

1. Eligibility criteria.

a) Existing Laboratory Attendant (erstwhile Gr. 'D' staff) completed of 3 years regular service in Medical Department as on the date of issue of this notification and passed 12th (10+2 stage) class with Science plus Diploma in Medical Lab. Technology(DMLT) subject to fulfillment of following conditions i) The course has been done from the institution which is recognized by a University or Technical Board of State Government / Central Government Authority ii) the duration of the course is at least 01 year iii) During the course the candidate should have done the training on full time basis; and iv) At the end of the course, there should be a system of examination which has been successfully past by the candidate (PCPO Sl. Circular No. 191/2015 and para 165 of IREM Vol-I).

b) Substitutes are not eligible to volunteer.

2. Mode of Selection

Selection will be made on the basis of competitive examination consisting of objective type and of multiple choice questions through regular answer sheets / OMR / CBT ; there will be 100 questions on subject concerned + 10 questions on Rajbhasha relating to Official Language Act, overall 100 questions to be attempted. Questions on Rajbhasha are optional. There shall be negative marking for incorrect answers, one third of the marks allotted for each question will be deducted for wrong answers , cutting, over writing, erasing or alteration of any type of answer will not be accepted, Zero marks will be given for answer having correction /over writing (PCPO Sl. Circular No. 240/2018). The competitive examination will continue for 2 hours duration. Qualifying marks for written test, 60% for UR and 50% for SC/ST, 20% for best amongst the failed candidates , if required number of SC/ST candidate do not qualified. Final panel is to be drawn based on seniority amongst qualified candidates.

3. Model Question Bank will be uploaded in the Eastern Railway website in due course.

4. Applications with the following deficiencies will be summarily rejected:-


